Please find attached a document with brief biographies of both Bob and I, as well as the most recent addition of our Big Issue that highlights some of our most recent work.

In addition to contents of the Big Issue, you may consider saying something about our budget increases this year.

Our \$1.75 Million for medically managed opioid abuse treatment has helped us implement programming with our providers that meets recommendations of SAMHSA and the Governor's Prescription Drug Abuse Prevention Council, to increase access to treatment for South Carolinians who struggle with opioid use. The majority of funds will provide medications and care to those who do not have the means to pay for private services.

Our appropriation for infrastructure will cover the purchase of a new building in Sumter for residential treatment beds serving women and children, as well as many projects to refurbish and update facilities that have become particularly rundown over time.
