Tori Beth,

Per Lt. Gov. Bryant's request, attached is overall SCEMD Recovery Status Report which outlines the amounts eligible for funding under each federal program for Hurricane Matthew, the 2015 Flood, and the 2014 Ice Storm. It also notes the federal share, non-federal share, and legislative appropriation for each event of which the consolidated disaster total is well over \$1B. A few items to note:

- The totals for each program for the 2016 Hurricane Matthew event will continue to fluctuate over the next few months.
- The estimates for the Columbia Canal and Williamsburg Regional Hospital projects at the time of legislative appropriation for the 2015 flood were considerably higher than the current estimates for eligible funding.
- The legislative appropriation for the 2014 ice storm was spread over several years and did not cover costs for state agencies. However, we were able to provide the cost share for state agencies (less DOT) from other appropriations.
