## First glimpse at next year's aging services funding

Earlier today, the Senate Labor, HHS, Education Appropriations Subcommittee approved its FY17 bill. Similar to last year, the Senate panel proposed a \$34.4 million (7.9%) cut in Senior Community Service Employment (SCSEP) funding, for a total of \$400 million. Elder justice

funding would see a \$2 million increase, to \$10 million, and most other services and benefits for older adults, such as Older Americans Act nutrition programs, the Low-Income Home Energy Assistance Program (LIHEAP), and Senior Corps, are all level-funded. Look for more details here next week.
