Thank you, but Im really trying to confirm numbers for a Board report. I want to verify that:

Under the EIA

- CDEPP (SCDE) was allocated \$34.3mn
- 4-k was allocated \$15mn

Under Aid to School Districts

- CDEPP (SCDE) was allocated \$12mn

Totaling Public CDEPP at \$46mn, with \$910k non-recurring.

Under the EIA

- First Steps was allocated \$26.2mn
- Of the \$26,2mn, \$9mn was allocated for private CDEPP

Totaling Private CDEPP at \$9mn, with \$490k non-recurring.

Under Aid to School Districts

- Reading Coaches were allocated \$29.5mn
- Summer Reading Camps were allocated \$6mn

Totaling \$35.5mn for coaches and camps, all recurring.

-I feel like I'm way off though, and I'm confused about the allocation for 4-k under the EIA (\$15mn).
