Dear Larry:

I am writing on behalf of my constituent, Heather Holloway (SSN: 248-73-5100), and her concerns that she may be wrongfully evicted from Beverly Apartments, 200 South Beverly Lane Apartment E104, Geer, SC.

Heather says that she is scheduled to attend court on Monday, August 27, 2007 because Minnie Davis, resident manager, is evicting her and refuses to renew her lease. Heather says she has not had a good relationship with management since her residency in Apartment C101. Heather says Minnie is upset that she has filed numerous complaints with HUD about her living conditions and treatment by management, thus serving as the catalyst for eviction. Some of Heather's complaints and concerns are as follows:

- Heather alleges Minnie refuses to renew her lease for personal reasons. Heather says Minnie failed her on the apartment inspection (Apt. C101) because of the condition of the guest bathroom. Heather says Beverly Apartments Maintenance Department failed to completely replace the sheetrock and tile thus causing mold and further sheetrock damage.
- Heather alleges Minnie failed to properly dispose of personal information for the tenants at Beverly Apartments thus violating privacy laws and failing to properly disposal of personal information. Heather says she filed a complaint with HUD.
- Heather alleges Minnie has failed to give her and other tenants their utility benefits checks in a timely manner, thus causing late fees and disconnection with utility companies; another reason she filed a complaint with HUD



Dear Ms. Howard:

This letter is in responds to a complaint filed with your agency by Ms. Heather Holloway a resident of Beverly Apartments located in Greer, South Carolina. In order to address the complaints that Ms. Holloway filed it is necessary to start at the beginning.

Ms. Heather Holloway moved into the community on July 7, 2005. At her move in orientation she was informed of the rules & regulations of the community and her lease was thoroughly covered with her before executing.

On October 11, 2005 a bi-annual inspection was completed and her apartment failed inspection. A re-inspection was schedule for October 18, 2005 and the apartment passed. **From this point to now Ms. Holloway has felted that I had a vendetta again her.**

On November 17, 2005 a lease violation was sent to her for unauthorized people living in the apartment. She was given 14 days to remedy this violation.

On December 20, 2005 a lease termination was hand carried and certified mail to Ms. Holloway for unauthorized people and disturbing the rights and comfort of her neighbors. There was an altercation on the property which involved Ms. Holloway and her unauthorized live-in guests.

On January 9, 2006, Ms. Holloway came to the office to discuss the proposed termination and she stated: "There was not a fight in her apartment, that the police was called because someone cut their hand in her apartment". She further stated: "she moved someone in with her because she had no other place to stay". I asked her if she knew she was in lease violation and she said yes. She further said that they moved in around Thanksgiving and moved out after Christmas and that they had a few clothes left in her apartment that would be removed that weekend. At this point I reiterated the rules & regulations and told her that I was going to document her file but this was her final warning.

On June 23, 2006 a biannual inspection was completed and her apartment failed. She was asked to clean the apartment including the appliances.

On December 7, 2006 a bi-annual inspection was completed and her apartment failed. The apartment was in deplorable condition. She stated that she was sick and couldn't clean up. Pictures was taken of the condition of the apartment and placed in her file. I told Ms. Holloway that I would be giving her a lease termination for failure to keep the unit clean and having authorized pets in the apartment. At this point I knew she was not going to adhere to the community rules & regulations. A lease termination was given on January 16, 2007. On January 23, 2007 Ms. Holloway had a grease fire, according to the fire department a pot was left on the stove and spilled grease onto the cooking eye and caused smoke to fill the apartment.

The stove was damaged beyond repair. I told Ms. Holloway that she was responsible for the damage and would be billed for the cost of the stove.

Ms. Holloway said that she was going to make trouble for me. That I was not going to evict her because she had called SC State Housing, The City of Greer Building & Planning Department, City of Greer Fire Department and the Health Department. She said that she told them that her apartment had mold and mildew and that her children was getting sick from it. On January 25, 2007 Mr. Phil Rhoads from the City of Greer completed an inspected of her apartment. He told me that he was going to condemn the apartment for mold and mildew and that the apartment must be certified by an environmental engineer. On January 30, 2007 I called Mr. Rhoads to ask him if he had mailed the condemnation letter, he said yes but he mailed it to the owners and not the property. Since I didn't receive a copy I called Marcrum Management, managing agent for Beverly Apartments to see if a copy had been forward to them. I told them that I was going to transfer the resident out of C101 to E104. The resident was given keys to E104 on January 30 2007.

On February 7, 2007 I received a call from Ms. Tracey Cobb from the Department of Social Services. She was inquiring about a Cory McWhorter and his two children. She wanted to know if he was on the lease at E104 because Mr. McWhorter gave E104 Beverly Apartments as his address and that he had been living there about two months. Ms. Cobb is Ms. Holloway caseworker and has an open case with her. Also she stated that she received a call from Mr. Carl Holloway stating that Mr. McWhorter was on drugs and didn't need to be around his children.

On February 21, 2007 Mold Professional came out and tested the unit for mold and mildew. The unit was certified mold and mildew free. His report confirmed that there had not been any signcant amount of mold or mildew in the unit that would cause a health hazard. A copy of the report was forwarded to The City of Greer.

On March 2, 2007 a show cause notice was filed at Greenville County Summary Court Judge Robert F. Simms for the failed inspection. The court date was set for March 29, 2007. The ruling was for the resident.

On March 30, 2007 Ms. Holloway came to the office at that time I told her that the Judge had ruled in her favor but she still had to follow the rules & regulations of the community. I told her that she must get a doctor's statement to show the need for a service animal in her apartment. She told me she didn't; the Judge said she could keep them. She also admitted that Cory McWhorter and his two girls was living with her and That she had called HUD because I put her in a unit to small for her family.

On May 4, 2007 I went to Commission of Public Work (CPW) because of a bill received in the office for the electric usage at E104. I was told that the utilities had not been transferred. I asked them to disconnect the services. When CPW came to cut the power off, Ms. Holloway came to my office irate; she brought her groceries and throw them in the office, went back and got more. When I saw her and Mr. McWhorter coming I called the police and locked the door. They were bammng on the door trying to get in when the police arrived. Ms. Holloway told me that I should have told her that I was going to have the power disconnected. I told her that she should have transferred her power back in January, she said well I didn't.

On June 7, 2007 the resident living in E106 called the Humane Society because E104 kittens were around her door. Upon their arrival Cory McWhorter told them he would get rid of the kittens. He took the kittens and put them in a drain at the H building. A resident in the H building called the Humane Society again and she has told that they couldn't touch the kittens because they were in litigation. We have cats running around on the property and Ms. Holloway and Mr. McWhorter has turned the children sand box into a cat litter. The Humane Society would pick the kitten up because they were told that the cats were in litigation

At no point have any action been personal or retaliatory. When Ms. Holloway said in open court that she moved her cats in when she moved in and that she had moved her boyfriend in (Cory McWhorter) it was evident that she had no intentions of following the rules and regulations of this community. She also called SC State Housing and spoke with Mr. Richard Rhodes and told him that she had cats and that her boyfriend

and his girls lived with her. Therefore, her lease with Beverly Apartments was not renewed. She is disruptive and is causing fraction on the property with some of the residents.

The new resident that moved in C101 has had a confrontation with her. Ms. Holloway told her that the apartment was full of mold and that her children were going to get sick.

When her water problems were brought to my attention I acted immediately on the problem to ensure that her and her family would not be living in unsafe conditions.

We believe that someone came into the office and stole papers off the desk. A police report was filed and all the locks were changed. Ms. Holloway came in possession of the papers and called an applicant and told them that their personal information was thrown away. This was the applicant moving into her old apartment. The theft was published in the County Line News on Tuesday July 31, 2007.

Marcum Management Company has an established method of operation and in no way hold utility checks from the residents. When funds are released for SC Housing Authority the resident checks are written and overnight to the property.

Presently, Ms. Holloway is living in substandard housing because the power is off. Ms. Holloway power was turned off on August 27, 2007 and she had been stealing power until yesterday, CPW came out and pulled the meter.

Thank you for your letter to Governor Mark Sanford dated March 1, 2006, addressing issues you are experiencing in your current residence at Pinewood Apartments. The Governor's Office has asked that our agency reply to your correspondence on his behalf since the South Carolina State Housing Finance and Development Authority (the Authority) administers the HUD Section 8 Housing Choice Voucher Program in Lexington County.

One of the major benefits of the Housing Choice Voucher Program is a participant's ability to select a residence that best meets their needs in an area they desire to live, so long as the unit is approvable for rental assistance under program regulations. Selection of an appropriate residence is an important matter, and issues concerning the condition of a unit or personal preferences need to be addressed and resolved with management prior to agreeing to the terms of and signing a lease. The Authority is prevented from advising you on those matters and can only address those issues that are clear violations of program requirements.

Many of the issues you address in your letter are covered under your lease with Pinewood Apartments, and are not program requirements. These items must be addressed and resolved with management or through legal action under the South Carolina Residential Landlord and Tenant Act. Although my staff shared your concerns with the management of Pinewood Apartments, we have no authority to require them to take any action concerning those issues that are not clear violations of program requirements.

When you contacted the Authority on Friday, February 24, 2006 concerning the problem with your heating system, you indicated that you had already contacted management and that they had scheduled a repair appointment for the next morning. This was within the 24 hour period allowed to respond to such maintenance issues. We attempted to verify this information with management but were unable to contact them, although we were reassured of their intent by the information you provided. We contacted management on Monday, February 27, 2006 and verified that corrective action had been taken. We also attempted to contact you the same day, but you were not available. You did however contact the staff on Tuesday, February 28, 2006 and confirmed that the matter had been addressed.



Thank you for your letter to Governor Mark Sanford dated March 1, 2006, addressing issues you are experiencing in your current residence at Pinewood Apartments. The Governor's Office has asked that our agency reply to your correspondence on his behalf since the South Carolina State Housing Finance and Development Authority (the Authority) administers the HUD Section 8 Housing Choice Voucher Program in Lexington County.

One of the major benefits of the Housing Choice Voucher Program is a participant's ability to select a residence that best meets their needs in an area they desire to live, so long as the unit is approvable for rental assistance under program regulations. Selection of an appropriate residence is an important matter, and issues concerning the condition of a unit or personal preferences need to be addressed and resolved with management prior to agreeing to the terms of and signing a lease. The Authority is prevented from advising you on those matters and can only address those issues that are clear violations of program requirements.

Many of the issues you address in your letter are covered under your lease with Pinewood Apartments, and are not program requirements. These items must be addressed and resolved with management or through legal action under the South Carolina Residential Landlord and Tenant Act. Although my staff shared your concerns with the management of Pinewood Apartments, we have no authority to require them to take any action concerning those issues that are not clear violations of program requirements.

When you contacted the Authority on Friday, February 24, 2006 concerning the problem with your heating system, you indicated that you had already contacted management and that they had scheduled a repair appointment for the next morning. This was within the 24 hour period allowed to respond to such maintenance issues. We attempted to verify this information with management but were unable to contact them, although we were reassured of their intent by the information you provided. We contacted management on Monday, February 27, 2006 and verified that corrective action had been taken. We also attempted to contact you the same day, but you were not available. You did however contact the staff on Tuesday, February 28, 2006 and confirmed that the matter had been addressed.


The staff's comments concerning the possibility of management providing space heaters and carbon monoxide detectors were only suggestions of additional requests you might make of management to provide more timely relief of your situation, and were not meant to imply a requirement on their part. We apologize for any misunderstanding this may have caused.

The Authority is concerned about the welfare of all of our participants; however, we may only require action by a landlord when there is a clear violation of program requirements. If they do not comply with program requirements, our only recourse is to terminate our contract and provide the participant the opportunity to receive rental assistance in a different unit.

We have discussed your numerous concerns with the management of Pinewood Apartments in an attempt to come to a resolution that is in the best interest of all concerned. Although you are still within the initial term of your lease, they have stated that they are willing to unconditionally release you from the terms of your lease. If you desire to move to another residence, please provide appropriate notice to the management of Pinewood Apartments, in writing, and provide a copy of your notice to the Authority. Once we receive your notice, we will make the necessary arrangements to cancel your rental assistance in your current residence and begin the process of assisting you in a different residence.



Dear Ms. Finklea:

The South Carolina State Housing Finance and Development Authority through its Contract Administration Division has investigated the complaints identified in correspondence dated February 15, 2006 in reference to the St. Stephens Apartments. Our records indicate the property has experienced problems and entered foreclosure in 2005. A foreclosure sale was initiated on November 30, 2005 with an expected closing date of January 6, 2006. However, in December several units burned and the closing date was extended pending a revaluation of the property. The subsidy contract was suspended in October as result of the foreclosure. In order to facilitate the foreclosure sale and preserve this affordable housing, the Department of Housing and Urban Development has authorized subsidy funding through June 2006. We have been advised that management has removed trash from the site and is in the process of responding to tenant complaints. We have been instructed by HUD that the renewal of subsidy for St. Stephens beyond June 2006 will be authorized in the form of Housing Choice Vouchers. The current subsidy is Project Based (attached to the actual property) and is not portable. The new subsidy contract will be portable and will force the owner to compete with other affordable housing providers both single family and multifamily. This will allow tenants the option to continue to live at St. Stephens or seek other available affordable housing options while retaining their subsidy.

Dear Dillon Herald:

Here are a few issues that I want to bring to your attention regarding the residents at St. Stephens Apartments. The property as you may be aware of was sold in November. The new owner was supposed to close on the sale in December but because of a fire they have been delayed. Edgewood management have not been paying bills trying to take all the money they can without doing anything for the property since about June of last year. You may have seen on the news where they stopped paying for trash removal and pickups stopped. They had to pay after we called the news out there. I think this is one of the reasons they fired the manager because she was trying to get them to pay the local vendors, rural sanitation and pest control at least.

The lights were turned off in the office and laundry room in December for non payment of the bill and every month Progress energy is out here threatening to turn the lights off. City of Dillon were threatening to turn off the water. A rat bit a tenant in November and Edgewood still won't pay them and have them come out, especially with the trash having got so bad. Edgewood was forced to pay trash removal, but the huge rats, and other animals had already come out.

Some apartments have sewage coming up from neighbors apartments and they are not doing anything about it. Miller used to come, but they were not paid for a long time and still may not be paid and won't come. Some one from Causey Carpet came to the office the other day demanding his money, but as always they only find the one maintenance guy that don't know nothing and too scared to call and make demands on our behalf.

A tenants refrigerator has been out for about 3 weeks now and the maintenance guy knows this. There are about 10 vacant apartments so I know there is a refrigerator that can be switched out. You can never talk with the so called manager they are now sending because he is only here maybe 2 hours a week and we never know when he is coming because he has not told us. He locks the storm door and we can't drop rent, but most of us don't trust Philip enough to drop rent anyway.

The fence that was purchased with grant money is broken and they refuse to repair to keep drug dealers out, it has really gone back to where it was 4 years ago.

I feel that if Hud is sending them money they should at least take care of the apartments and pay people to work if they are not going to work. Pittsburg Paint won't repair windows. They are not paying vendors, someone should follow the money trail because it appears they are trying to run the property down before the new people take over.

Some of us have not paid rent because we don't have anyone to pay it to and besides that they are not repairing anything. If we are having to move, why pay rent? We are told by

housing authority that the new man backed out, so where does that leave us. All Edgewood had told us is that things are remaining the same. The same is not repairing and paying bills then, why are we paying? They have no money to purchase even glue board for rats that we have been begging for but they paid for about 15 or more evictions last week. Where did that money come from.

Some one might want to look at Edgewood a little closer especially what they are doing for St. Stephens.

Some one need to do something because this letter is being sent to a lot of people.



It was a pleasure to speak with you on today. I thought that it might be helpful if I were to follow-up with you in writing since we covered quite a bit of information during our conversation.

In an effort to provide Ms. Singly with some immediate housing options, we discussed the following:

1. If she is willing to relocate to Kershaw County, the Section 8 waiting list is open and she would stand a good chance of obtaining a housing voucher. Applications will be accepted by phone on February 8, 2006. The number is 1-866-701-0314.
2. The Authority staff has talked to the property management staff at Wardlaw Apartments on Elmwood. The management staff has indicated that they would be willing to waive the deposit and application fees. In addition, they would let Ms. Singly have a one bedroom apartment for \$395 per month.
3. The Lt. Governor's Office on Aging administers a program that will provide some rental assistance for up to three months. Contact Nela Gibbons at 734-9910.
4. The Authority has also located a property in its rental inventory that is near the airport. Due to its isolation and other questionable activity, I would not recommend this property for an elderly woman.
5. The Columbia Housing Authority provides rental assistance for Richland County. While their waiting list may be closed for the Section 8 Program, you may want to inquire about available public housing. Their number is 254-3886.
6. Currently the waiting list for Lexington County is closed but has approximately 750 persons awaiting rental assistance. Of that amount, about 450 of those persons would qualify for preferences (disabled, elderly, veteran) and will probably have to wait at least two years for rental assistance.

I trust that this information will be helpful to you in trying to assist Ms. Singly. You may contact me at 896-9292 if I may be of assistance to you again.




