Coordination of benefits in Medicaid: A new handbook

The Centers for Medicare & Medicaid Services (CMS) has released a handbook clarifying several policies about how Medicaid coordinates with other programs. In particular, the guidance explains that Older Americans Act services are an exception to the "Medicaid is payer of last resort" rule, and elsewhere emphasizes the prohibition on balance billing of Qualified Medicare Beneficiaries (QMBs).

If you have clients who received their diabetes testing supplies from Arriva Medical, they should have received a letter stating that the company is no longer enrolled in Medicare as of Nov. 3, 2016. Beneficiaries can locate another mail order supplier for their diabetes testing supplies by searching the Medicare Durable Medical Equipment Competitive Bidding Supplier Directory or by calling 1-800-MEDICARE.
