IN RE: Data Request for CDEPP Evaluation

I am following up on the initial report on the Child Development Education Pilot Program (CDEPP) that was released on January 21, 2014. To complete the requirements of Provisos 1.83. and 1A.34. of the 2013-14 General Appropriations Act, the Education Oversight Committee (EOC) respectfully asks that you provide the following student-level data by **June 4, 2014**. The information in an Excel file is sufficient. The information requested is not personally identifiable information but student-level information needed to evaluate the program and monitor student progress over time.

1. For the 2013-14 school year, the EOC needs the following student-level information on each CDEPP-eligible student who was enrolled in CDEPP as of the 135th day of the program.

- Unique student identifier for each enrolled child
- Three (3) characters of the child's last name and two (2) characters of the child's first name
- Date of birth
- Race
- Gender
- Eligibility criteria (Free/reduced price lunch eligibility and/or Medicaid)
- Name of school or private provider enrolled
- Date of enrollment in the program
- Any student-level assessment data collected and provided by the provider to your agency or office

* If there are any non-CDEPP eligible students in the CDEPP classroom, student-level data, if available, should also be provided.

2. To continue the EOC's longitudinal analysis of summative assessments, the EOC needs the same student-level data for the 2009-10 school year. Again, the 135th day of enrollment is sufficient. Because the evaluation of the program ended with the 2010-11 Fiscal Year, the EOC did not receive student level data for the 2009-10 school year. However, per Proviso 1.62. of the 2009-10 General Appropriations Act, the Office of First Steps to School Readiness and South Carolina Department of Education were required to maintain a database of the children enrolled in the program and verify student enrollment eligibility with the Department issuing a unique student identifier for children enrolled in public and private centers.

- Unique student identifier for each enrolled child
- Three (3) characters of the child's last name and two (2) characters of the child's first name
- Date of birth
- Race
- Gender
- Eligibility criteria (Free/reduced price lunch eligibility and/or Medicaid)
- Name of school or private provider enrolled
- Date of enrollment in the program
- Any student-level assessment data collected and provided by the provider to your agency or office
