SECTION 1: The Minutes for the meeting of November 18, 1994, copies of which had been previously mailed to each member of the Commission, were approved.

EXTENSION OF BITUMINOUS RETREATMENT CONTRACTS
TO INCLUDE ADDITIONAL RESURFACING WORK

It is recommended that the Commission approve the action of the Department in extending existing bituminous retreatment contracts to include additional resurfacing work as follows:

Beaufort County:

Contract of J. F. Cleckley and Company - File Nos. 7.1079 and 7.574 - extended to include an additional section of Project C-574 (File No. 7.574) consisting of resurfacing of 0.30 mile on Road S-52 from Road S-5 easterly; 0.30 mile on Road S-116 from Road S-96 to Road S-96; 0.30 mile on Road S-158 from US 21 easterly; 0.60 mile on Road S-289 from Road S-488 to Road S-256; 0.20 mile on Road S-489 from Road S-488 to Road S-256 and 0.20 mile on Road S-512 from Road S-289 to Road S-289.

Estimated Cost of Extension \$48,425.79

Horry County:

Contract of APAC-Carolina, Inc. - File No. 26.10101 - extended to include resurfacing (File No. 26.10101) of 0.12 mile on Road S-485.

Estimated Cost of Extension \$ 8,914.37

Lee County:

Contract of APAC-Carolina, Inc. - File Nos. 31.1058 and 31.438 - extended to include an additional section of State Project C-438 (File No. 31.438) consisting of the resurfacing of 0.22 mile on Road S-31-212 from S-31-422 to end of pavement and 0.10 mile on Road S-31-361 from S-31-423 to Thomas Street.

Spartanburg County:

Sumter County:

Contract of APAC-Carolina, Inc. - File No. 43.1085 - extended to include resurfacing (File No. 43.1085) of 0.80 mile on Road S-43-94 from S-43-82 to US 521.

These extensions were authorized by the Department prior to formal approval by the Commission since the adjacent work had reached such a stage of completion that the contractors involved could not accept the additional work unless it were authorized without delay.

**Statement by
H.B. Buck Limehouse, SCDOT Commission Chairman
on the
Hilton Head Cross Island Connector**

Today's vote by the South Carolina Department of Transportation Commission to move forward with the Hilton Head Island Cross Island Connector did not come without serious and laborious debate and analysis over construction of the project.

We take to heart each of the concerns we've heard over time and in the past week from citizens, residents and people who work on the Island. I can assure you that the South Carolina Department of Transportation will exercise extreme sensitivity in approaching this work - sensitivity to public concerns, sensitivity to the environment, sensitivity to noise pollution and sensitivity to the beauty of the project. But most of all we are empowered by the state to be sensitive to the transportation and safety needs of the public. The Cross Island Connector can meet each of these goals.

Today's vote comes with a mandate to SCDOT engineers and other project staff to develop a partnership with the Town Council, Island leaders, federal and other state agencies responsible for permits for this project and others to ensure that concerns are addressed and that this project will set the example for how future projects will be approached.

This type of partnership is not new to the Department of Transportation. Last year we dedicated a bridge near Charleston called the Isle of Palms Connector which began with many of the same concerns that Hilton Head residents and leaders have about this project.

But because we took the time to listen and we sought creative solutions to environmental and transportation challenges, we invented the new national standard for building bridges through pristine salt marshlands. Transportation needs were met and environmental goals were surpassed on this nationally recognized project.

- MORE -

We will reach that mark with this project, too. Construction of the Cross Island Connector must be done in a way that it protects the health of the coastal ecosystem, that it builds a coalition of partnerships in the community and that it meets the safety, health and well-being of Island residents and visitors.

We look forward to beginning this project soon. Thank you!
