The affiant states that there is probable cause to believe that the defendant named above did commit the crime(s) set forth, and that such probable cause is based on the following facts:

That on September 14, 2016, at approximately 1630 hours while near 4506 Garwood Dr., Ladson, in the County and State aforesaid, the above named defendant, **JUMAHN RAYMAR TOLBERT**, did commit the offense of violation section 16-11-330 of the South Carolina State Code of Laws, 1976 as amended, **ARMED ROBBERY**, in that he did willfully, unlawfully, and feloniously, while armed with a handgun rob the victim of \$225 in cash.

The victim stated that the subject provided a meeting place of 4506 Garwood Drive. The victim stated when he arrived at the meeting destination the subject got into his vehicle where they communicated about the phone. The victim stated he pulled out his wallet to pay for the phone, at which time the subject produced a black pistol and racked it. The subject told the victim "give me everything you got or I will cap you". The victim stated that he handed the subject \$225 from his wallet, at which time the subject got out of the vehicle and walked away.

Detective Wilson corresponded with Letgo and established biographical information along with messages that identified the defendant as a possible suspect. Further investigation revealed that the defendant lives in close proximity of the incident location. He also fits several other victim descriptions of a subject that has committed recent robberies using the Letgo service in the Woodside neighborhood. The subject who committed the crime and an iCloud account believed to belong to the defendant was used during these Letgo transactions.

From this information Detective Wilson conducted an investigation and established probable cause for an arrest of the defendant in two other cases. On 09/19/2016, Det. Wilson arrested the defendant at which time he was advised of his rights. The defendant signed and acknowledged he understood and provided a video recorded statement where he confessed to this incident and the others.

The above information was revealed through the investigation of Detective M. 





From this information Detective Wilson requested a photographic line-up from the Charleston County Detention Center containing the defendant. On 09/15/2016 Det. Muirheid met with the victim and witness to show them the line-up. Both the victim and witness were shown the line-up separately and both positively identified the defendant as the assailant who committed the robbery.

The above information was revealed through the investigation of Detective M. Wilson, of the Charleston County Sheriff's Office, and that he along with the victim are witnesses to prove the same against the form of the statute in such case made and provided for against the peace and dignity of the state.

(Charleston Chase) On the above date and time I responded to the incident location in regards to an armed robbery. Upon arrival I activated my body camera and met with the victim (Miles) and complainant (May). Miles reported that she contacted the suspect (Dixon) via the Let Go app about a phone that he had posted online for sale. Miles advised that she asked him to meet up at Burger King to complete the transaction, to which he refused giving the location of the Charleston Chase subdivision as a meet up location due to not having a ride. May gave Miles a ride to meet with Dixon and witness the transaction. When they arrived at Charleston Chase Dixon got in that backseat of the vehicle and handed Miles the phone. Miles advised she handed Dixon 80 dollars in cash and Dixon stated "let me see the phone so I can take off the password." After taking the phone back he pulled out a black handgun from the waistband of his shorts, and stated "you're not getting the money or the phone". Miles demanded her money back from Dixon to which he replied "I'll beat your ass!" Miles advised Dixon then jumped out of the vehicle, and ran through a vacant lot into a wooded area that is connected to the Woodside Manor. Miles describe the handgun as being black, small, and semi-automatic possibly a pellet gun or 22. Miles described the suspect as a black male approximately 16-18 years old wearing a black tee shirt, black basketball shorts, and a small afro. Responding deputies patrolled the area and were unable to locate the suspect. I was able to get a screen shot of Dixon's account on the Let Go app which was burnt on to a CD and placed into evidence. I contacted Deputy Wean who worked a robbery case# 2016-013643 last week in the area that involved the Let Go app. The items Weans suspect had posted matched the ones Dixon had on his account. They were posted under different names and it appears the suspect is using multiple accounts under fake names. The account names involved in Weans case were Blaxk Ninja, and Deon Brown. There was also a picture of the suspect on the Deon Brown account. I forwarded it to the supervisor and to North Charleston SRO's who work at Stall High School in an attempted to find identify the suspect.

Sturgeon stated that she handed the suspect the \$80 and then he fled towards the front of Woodside Manor on foot. Sturgeon stated that the name the seller was and is still currently using on the Letgo App is Ramone Dixon and he is currently selling items on Letgo in the Ladson area. I then had Sturgeon take screenshots of the Letgo App page of the seller and email them to me in order to place into evidence. Sturgeon and Deleon couldn't provide any further information or description of the suspect. As I continued the investigation I was also able to look up Ramone Dixon on the Letgo page and discovered that he also goes by the name of "Reesey G". I was able to send an e-mail to the Letgo company in regards to them being able to provide information on their users by email request only. The website states that it can take up to 72 hrs for them to respond. I will follow up with the company once I receive an e-mail reply back. Nothing further.

(North Charleston) On the above date and time while continuing the armed robbery to person investigation that occurred in Woodside Manor on 9/13/16 I checked my county e-mail and noticed a reply from (Kristin), who is an employee with the Letgo company, in regards to attempting to identify the possible suspect that goes by the moniker "Reese G" on the Letgo App. Kristin stated in the e-mail that she was able to look up Reese G's account and provided a detailed list of information to include his address, user id, and a detailed list of conversations this individual has had with multiple people in regards to selling items using this app. Kristin stated that his user id is jumahn98@icloud.com and that his listed address is 4513 Outwood Drive in Ladson, SC, which is located in Woodside Manor. Kristin also provided Reese G's ip address of 66.87.132.57 and also provided the type of cell phone used, which is an Apple iPhone 6s, registered on the Sprint Network. When I began to look at some of the conversations that Reese G has been having with potential buyers I noticed that he gave his actual physical address, multiple times in different conversations, as 4564 Garwood Drive in Ladson, SC which is close to the location where the armed robbery occurred. I also noticed that this individual also gave his phone number of 843-377-6406 in a conversation in order to text back and forth. I then began to investigate further and looked up the 4564 Garwood Drive address in our RMS system and looked for all individuals living at the address. Upon searching I discovered a person by the name of (Jumahn Tolbert) who matches the physical descriptors and age that victim #1 (Sturgeon) provided. Also upon looking into it further I noticed that the user id Letgo provided for Reese G of jumahn98@icloud.com also matched the first name of the Tolbert suspect. I then was able to lookup Tolbert's SCDMV record and confirm that the address that was on file is 4564 Garwood Drive in Ladson, SC. I then downloaded the conversations and submit them into evidence. I notified Sgt. Bryant in CID he directed me to get in contact with Detective's M. Wilson and W. Muirheid currently assigned to the case. I met with both detectives and gave them the information that I discovered for further investigation. Nothing further.

(Woodside Manor) On the above date and time I was out at Hwy 78 Discount Mart in reference to an unrelated call when I was flagged down by the victim (Pedroza) in regards to an armed robbery. Pedroza reported that he contacted the Unknown suspect who was using Reese G. as an account name for the Let Go app (App used to post and sell items). Pedroza stated that he contacted the suspect about a phone that he had posted on his account for sale. Pedroza advised that the suspect asked him to meet up at his house at 4506 Garwood Drive to complete the transaction. When Pedroza arrived he observed a black male standing near a mailbox. Pedroza let the suspect in the passenger seat of the vehicle. Pedroza stated that the suspect handed him the phone and Pedroza noticed that Reese G's account was still on the phone so he asked him to take it off. The suspect stated "I have to go back in the house to get on the wifi to reset it." Pedroza advised that he pulled out his wallet and the suspect pulled out a black semi-automatic handgun racked it and stated "give me everything you have or I'll cap you!" Pedroza reported he handed the suspect \$255 dollars in cash. Pedroza advised the suspect then got out of the vehicle and walked away. Pedroza described the suspect as a black male approximately 14-16 years old wearing a navy blue Hooded Sweatshirt, black shorts, with the hood over his head tied just exposing his face. Responding deputies patrolled the area and were unable to locate the suspect, and the address given doesn't exist. There is a 4504, and a 4508 but no 4506. Pedroza provided a written statement of the incident and advised that he would email me a screen shot of Reese G's account on the Let Go app, and the messages to be added as evidence. Deputy Wean and I recently worked similar robberies case# 2016-013643, and 2016-013847 last week in the area that involved the Let Go app. The items in both cases the suspect had posted matched the ones on Reese G's account. The victims descriptions of the suspect are all similar as well. The account names involved in Weans case were Blaxk Ninja, and Deon Brown, and the account used in my previous case was Ramone Dixon. Detective Wilson arrived on scene and took over the investigation.
