Mr. Poore called the meeting to order and Councilman Joseph G. Wright, III gave the invocation.

On the motion of Mr. Wright, seconded by Mr. Bratcher, Council voted unanimously to approve the February 26, 1982 minutes as mailed.

Mr. Watson presented a budget transfer for the Public Defender. On the motion of Mr. Wright, seconded by Mr. Bratcher, Council voted unanimously to allow the Public Defender to transfer from account #128.10, \$35.00 to account #128.82.

Ms. Cathy Crum from the McNair Law Firm asked for approval of Resolution #145 and an Assistance Agreement for Mack Evan Products, Inc. On the motion of Mr. Hooper, seconded by Mr. Bratcher, Council voted four in favor to approve the resolution. Mr. Wright abstained.

Mr. Mac Walters asked Council to accept Morgan Woods into the County system. On the motion of Mr. Hooper, seconded by Mr. Wright, Council voted unanimously to adopt into the County System. On the motion of Mr. Wright, seconded by Mr. Hooper, Council voted unanimously to accept Country Lake Estates into the county system also.

Mr. Laniel Chapman spoke on the need to form a committee to determine what type voting method would be feasible for Anderson County. Council agreed to appoint Mr. Chapman as chairman of the committee and to report back to County Council at their next meeting with four recommendations for a nine member committee at which time the County Council will appoint.

Mr. Rhodes presented third and final reading of Ordinance #73 (Crime Watch Signs). On the motion of Mr. Rhodes, seconded by Mr. Wright, Council voted unanimously to approve Ordinance #73 on third reading.

Mr. Karl Kenyon presented Ordinance #79 (Bond Ordinance for Orian Rugs) and Ordinance #81 (Reconveyance of Properties - Orian Rugs) for second reading. On the motion of Mr. Hooper, seconded by Mr. Rhodes, Council voted four in favor to approve. Mr. Wright abstained. (See Attached)

On the motion of Mr. Wright, seconded by Mr. Hooper, Council voted unanimously to approve Resolution#146¬ice of public hearing for Southside Rural Community Water District.

Mr. Watson discussed the need to transfer money into certain accounts for past due bills. On the motion of Mr. Hooper, seconded by Mr. Kinley, Council voted unanimously to direct the County attorney to get a legal opinion on the Health Department's salaries.

On the motion of Mr. Wright, seconded by Mr. Hooper, Council voted unanimously to a change order for the Anderson County Office building which involved constructing two walls to form a waiting room for the Supervisor and Purchasing Agent.

On the motion of Mr. Hooper, Council voted unanimously to adjourn at 9:47 a.m.
