Dear Anirudh Saxena,

I am in receipt of your email sent to the South Carolina Department of Health and Human Services November 14, 2011 requesting information for your report on the Home Healthcare Market.

Please be advised that the Medicaid Home Health and Hospice programs in South Carolina do not cover home fusion and home respiratory services. The Home Health program covers three specific therapies: physical therapy, occupational therapy and speech therapy. The Medicaid Hospice program covers some therapies, but the rate is an all inclusive per diem, and the number of actual therapies received by Hospice patients is not tracked.

If you would like information on the number of visits on the three covered therapies in home health, please advise what time period you need and we may be able to provide that data to you.

If you are requesting specific provider information, please make a request through our Information Officer, Jeff Stensland at stensjef@scdhs.gov.
