Senator Danny Verdin and Representative Garry Smith contacted our agency on your behalf regarding assistance with your mother, Mrs. Betty Williams, and her healthcare needs.

Mrs. Williams has been found financially eligible for medical coverage through Medicaid's Nursing Home program effective August 1, 2008; however, she is ineligible for vendor payment to a facility until December 2009 due to a penalty incurred when Mr. and Mrs. Williams' home was transferred to you.


Mrs. Williams' eligibility is being negatively affected because it appears that she transferred her home without receiving the appropriate value. Nursing home eligibility requires that we look at an applicant's income and the amount of assets that they have available. Eligibility rules also require state Medicaid programs to determine if there were assets transferred or disposed of in the 3-year period preceding the month of the nursing home application. We are required to determine the Fair Market Value of the asset that was disposed of and treat that value like it could be used to pay for her care. This period is referred to as a penalty period.

When we apply a penalty period, we are able to provide a Medicaid card that covers doctor's visits, prescriptions and other general services. Until the penalty period expires we are not able to pay for the room, board or other nursing home services.

You requested to apply for an undue hardship on behalf of your mother and her eligibility worker, Ms. Tiffani Stone, has requested that you return a letter from Mrs. Williams' physician verifying that a discharge from the facility would result in a life-threatening situation. Once this information is received and a decision is made, we will notify you.

Actually this case should have been approved without a vendor payment a long time ago. We have been going

back and forth with this family for some time. The letter from the doctor was requested on a Form 1233 the first time on December 4, it was requested a second time on a Form 1233 December 23. We have not received it as of today. Policy states that a letter from a physician verifying that a discharge from the facility would result in a life threatening situation is what is needed to accompany the undue hardship request (Section 304.08.03). But like I said before the information we received from Betty Moses previously made it sound as if undue hardship would not be approved. If undue hardship is not approved the family is looking at a penalty. The case would be approved without a vendor payment until December 2009. The family indicated that the property was originally transferred to avoid having Medicaid take it so I am not sure what bearing this will have on the case with Policy and Oversight. The option of transferring the property back to Mr. and Mrs. Williams and avoiding the penalty was given to the daughter and her husband but it seems that they are not willing to do this. Mr. and Mrs. Williams could then transfer the property to just Mr. Williams since transfers are allowed between spouses.

Since this case has been pending since August, we are anxious to get it completed. Would it be alright for us to go ahead and approve the case without a vendor payment while we are waiting on the outcome of the undue hardship?



Honorable Senator DeMint:

I am writing on behalf of my parents. I feel a sense of urgency and desperation. I am an only child, my parents are both infirm and require care.


My mother, Betty Williams, who was officially diagnosed with dementia in Jan. 2006, has deteriorated to the point of being bedridden, requiring total care. She is currently residing at Summit Place Nursing Home in Simpsonville. SC. We are seeking Medicaid funds to help provide for the cost of her care.

My father and I took care of her at home until her health declined. On July 23rd. 2008 she was admitted to Fountainside Eldercare, on August 1st she fell and broke her hip and was hospitalized for surgery.

She has been penalized certification of Medicaid funds until Dec. 2009. The reason, I feel, the penalty occurred was because in Aug. 2005 my parents estate was transferred to my name and then in Dec 2006 it was transferred to a life estate for my father, Roy Williams. I am not trying to defraud the government in applying for Medicaid funds for my mother, Betty Williams. I am only asking for help. My father is on a fixed income, he is paying out most of his life's savings in my mother's care.

The reason these changes of estate were made was because my father was at the point of death, and my mother, who was already showing signs of dementia, needed constant care. My father's wishes were for this to be done for her benefit and welfare. My father did recover enough to return home. He remains in poor health; his disabilities include crippling rheumatoid arthritis, renal disease, emphysema-requiring oxygen, heart disease, colon cancer survivor. His last hospitalization was in Jan. 2007, when he again was near death, but again recovered to come home. He is no longer able to care for his wife. I currently care for my father's needs; but it would be impossible to care for both parents.

I am sure you hear of many hardship situations at your office. I do not know who else to turn to for help. I would appreciate your consideration in reviewing this situation, and hopefully, prayerfully assisting my mother, Betty Williams, in the granting of Medicaid funds. I do request a reply.
