**Subject: Local Board Appointment Process Changes Today**

Ladies and Gentlemen,

This is a reminder that the appointment process for local boards changes **today**. Delegations and other nominating authorities will continue to screen and nominate candidates based on their established procedures. Once the candidate has been selected, nominating authorities will submit the nomination letter (recommended template attached) to the Governor's Office via U.S. Mail.

The main difference in the process is that nominating authorities no longer need to submit the Governor's Office Application with the nomination letter. Once the nomination letter is received by our office, our staff will email the candidate a link to the online application. CR Forms (for foster care review boards ONLY) will still need to be included in paper copy and sent in with the nomination letter, until further notice.

Again, **these changes go into effect today, Monday, January 2, 2017**. Please feel free to distribute this email and attachments to anyone I may have left off of this list and do not hesitate to contact me if you have any questions.
