Hi, Skip. Per our conversation, I have made what appears to be a major discovery via the South Carolina Press Association. I spoke to them yesterday and then was shown the link on their website. According to their explanation of SC FOIA law, "A 'public body' is any entity supported by public funds, even in part, or that expends public funds ... Even non-profit agencies and **Chambers of Commerce** that receive public funds are subject to the FOIA."

That also means that Lowcountry Economic Alliance is clearly subject to FOIA.

The preceding quote is from the question, "Who or what is covered by the FOIA?"

Hopefully, this will become the "smoking gun" when it comes to ending any claim by the HH Chamber/VCB that they are NOT subject to FOIA.

And this is obviously also in keeping with the judge's landmark ruling in the New Orleans CVB case last year.

Again I want to have copy of all emails and explanation on inside and outside involvement with Jane Upshaw including Tom Upshaw , Palmetto electric , Bill Miles and hhi chamber including any executive board members for

insurance policies issued and not bid out , including all other goods and services issued to companies and individuals listed and explained in detail . Please include any involvement of Steve Riley , Drew laughlin , any officials in Beaufort not just HHI with LEA . Basically a list and explanation of anyone connected to LEA in any form or fashion .

The HHI chamber is separate and much will be discovered once an independent audit begins and is complete . This will be regardless of your efforts to hide and skirt info under sc FOIA laws . Thx
