Mr. Poore called the meeting to order and Councilman Wright gave the invocation.

On the motion of Mr. Rhodes, seconded by Mr. Gerrard, Council voted unanimously to approve the February 19, 1980 minutes as mailed.

Mr. Larry Stone, President of Home Builders Association of Anderson, asked Council once again that a member of their group be named to the Anderson County Planning and Development Board. County Council received as information.

Mr. Clinton King, Director of the Anderson County Solid Waste Management Authority, appeared before Council requesting additional funds to complete the fiscal year 1979-80 due to outrageous price increases on fuel, oil and equipment parts. Council received as information.

Mr. David Watson presented Ordinance #49 (Amendment to 1979-80 Budget) for first reading. On the motion of Mr. Rhodes, seconded by Mr. Gerrard, Council voted unanimously to approve on first reading.

Mr. Robert P. Lusk presented Ordinance #48 (Anderson County Recreation Commission) for second reading. On the motion of Mr. Wright, seconded by Mr. Hooper, Council voted unanimously to adopt on second reading.

On the motion of Mr. Wiles, seconded by Mr. Hooper, Council voted unanimously to transfer \$53,000 from Building Maintenance account #158.01 and 158.80 to the Anderson County Solid Waste Authority's 1979-80 Budget, and transfer \$2,000 from the Contingency Fund - Account #910 to the Treasurer's budget 152.10 (Adv., printing and office supplies).

Mr. Robert P. Lusk asked that Council go into executive session to discuss legal problems regarding Act 208.

On the motion of Mr. Gerrard, seconded by Mr. Rhodes, Council voted unanimously to go into executive session at 9:40 a.m. On the motion of Mr. Hooper, seconded by Mr. Wiles, Council voted unanimously to reconvene at 11:15 a.m.

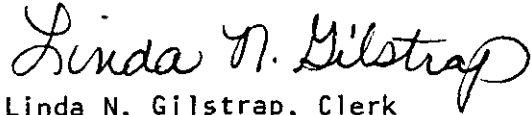
Mr. Brantley Jordan protested against closed door sessions.
