Hello Catherine,

I contacted National Board yesterday to ask if they can provide any data about the the number of SC teachers who were able to obtain National Board Certification without retaking any of the components. I haven't received a response and hope they will get this information to me quickly. As you may know, National Board revised their process a few years ago. Under the new National Board system, initial candidates have three years to make an initial attempt at the four required components. This means that a candidate who certified on his/her first attempt may have still taken three years to certify. I am happy to talk with you, if you have additional questions about the process or the program.
