I tweaked our statement a bit – there was a question of whether it allowed movement throughout our state and I want to be clear that it does. Last night the weather conditions were unfavorable so the repair is not where they had expected, and likely the repair will not be completed until next week. They did get the line open from Houston to Alabama. They also have started a contingency plan using another line. The DOE is providing an update at 2 PM if we want to wait for additional information.

Also, SCPMA (SC Petroleum Market Association) just got called from WIS to provide a response. They have not provided it yet. Rob or Chaney do you want to talk with them? We do not want to start a run on the gas pumps.

Haley issued an Executive Order September 14th stating that an emergency exists in South Carolina for the purpose of complying with the emergency declaration in Georgia. She has directed both DOT and DPS to ensure the uninterrupted movement of gasoline and other fuels through our state to assist Georgia. We will continue to monitor the impact this event has on South Carolina, taking appropriate action as necessary.”

We issued an Executive Order Wednesday declaring that an emergency exists in SC for the limited purpose of complying with the GA emergency (see attached). Also, a Colonial representative reached out yesterday saying they thought the impact to SC would be minimal, although they weren't completely sure what that impact would be. We could say something to the effect of:

“In response to the situation in Alabama and Georgia, Gov. Haley issued an Executive Order determined that an emergency exists in South Carolina for the purpose of complying with the emergency declaration in Georgia. She has directed both DOT and DPS to ensure the uninterrupted supply of gasoline and other fuels needing to be moved through Georgia. We will continue to monitor the impact this event has on South Carolina, taking appropriate action where necessary.”

Gov. Bentley of Alabama and Gov. Deal of Georgia have issued states of emergency in regards to fuel availability and potential shortages. As you can see from the map, the pipeline runs through larger sections of AL and GA than it does SC (it only hits the Upstate). Is Gov. Haley concerned that South Carolina's fuel supply may be affected? A statement from Colonial Pipeline, the owner of the pipeline that spilled, said that South Carolina would be among the first states affected by any "potential disruption in supply."
