Good Morning-

Can you please send me any Office of the Lt. Governor or LGOA accomplishments you believe are worthy of being placed into the 2017 Agency Accountability Report. I am looking for actual achievements outside of the routine services we provide. Please provide your accomplishments/achievements by August 14, 2017.

For example:

- The LGOA held Senior Day at the Statehouse to commemorate Older Americans Month on May 4, 2017. Over 700 seniors attended this event, where they received valuable information about senior services, had an opportunity to interact with their elected representatives and senators, received health screenings, participated in health and wellness exercises, and were provided entertainment and lunch. The event was funded through private sources.
- The LGOA submitted its four year State Plan to the Administration for Community Living for 2017 – 2021 in August. The Plan which was approved by the Assistant Secretary for Aging with the United States Department of Health and Human Services (USDHHS) provides a guide and blueprint that demonstrates how the Lieutenant Governor's Office on Aging will deliver aging services throughout the duration of the plan. The USDHHS requires approval of State Plans before the State Unit on Aging can receive federal funding.
- The LGOA spent 2017 finalizing its new assessment policy. In 2017, the LGOA contracted with Clemson University to provide uniformed training to Area Agency on Aging (AAA) staff conducting assessments in advance of the policy taking effect on July 1, 2017.
