Pursuant to your recent telephone conversation with Trish Crouch of SCDOT Toll Operations, I am enclosing an Installment Agreement form. The Agreement requires you to make payments of \$114.00 per month (1 payment of \$115.75), beginning July 3, 2012, and continuing until the entire amount of \$1369.75 has been paid. 


