**Subject:** NOC update

Neighborhood Outreach Connection ( NOC) has had an exciting yet challenging year. We had more than 200 children enrolled in NOC's pre-school and after school programs in HHI and Bluffton during the Winter/Spring Session in 2014. In the past twelve months NOC, along with its health care partners, screened more than 300 people under its health care program. Much thanks to those Rotary Clubs that offered their support to make these programs successful.

As your Rotary year draws to a close, should you find that your Club has an annual budget surplus, we'd like you to consider financial assistance to NOC in order to continue its programs to educate underserved children right in their own neighborhoods. Please consider the following:

1. Bluffton House: New owners chose not to renew NOC's two "section 8" apartments. The end result—75 students from our program at Bluffton House lost the opportunity to attend NOC. We are now struggling to pay for one apartment at a cost of \$1000/month. A donation of \$12,000 for one year's rent of one apartment or \$24,000 for two apartments would solve this shortfall.

2. Cordillo Apartments: NOC opened here in time for the spring semester. We have twice the current students of 35 on our waiting list and we are anxious to begin the Virtual

Summer Learning Program in partnership with the Beaufort County School District. The purchase of two units at Cordillo were made possible thanks in part to a Community Foundation Grant. However, we need \$25,000 to finance staff and supplies so NOC can handle its rapid growth here!

We would appreciate any financial help you can provide to NOC as your Rotary year ends, or as the new Rotary Year begins. We are prepared to meet with your officers at your convenience to discuss this request
