"Conway - First responders rescued dozens of Conway residents from rising waters Monday, a product of flash flooding after a downpour from Hurricane Florence."

"The City of Conway had conducted 12 water rescues by noon Monday. Horry County had saved about 25 residents by 8 a.m. And a National Guardsman told The State (newspaper) he had lost count of the Conway residents they had picked up in high-water vehicles."

"Many of the evacuations took place in north Conway's Sherwood neighborhood, where residents watched Monday morning as water steadily rose from the nearby Crabtree Swamp, a tributary of the Waccamaw River."

" 'I might lose everything I've got,' said Jess White, a lifetime Conway resident who has never before had to evacuate the home his grandfather built on Busbee Street."

SC Personhood Bill ( [S217](#)): [died](#) after coming onto the SC Senate calendar during the regular 2018 Session of the SC Legislature, after it had finally [passed](#) favorably out of the Senate Judiciary Committee February 20, 2018, having been filed as legislation in the SC Senate, over a year earlier, on January 10, 2017.

Is there sufficient fear of God in the SC Legislature ( Senate and House ) and in the SC Governor's Office to call for a special session to accomplish their sworn duty to " [establish Justice](#) " for human beings ("persons") in the womb ?
