REQUEST TO DISMISS CHARGES

I Darrel Chinn have been Unlawfully Charge with a Seat Belt Violation by Mr. McAdams. I have Retired out EARLY from the United States Postal Service as a City Carrier in May 2009, on Disability, and I have Not had any kind of Traffic Violation charged Against me since I was a Teenager, I am 54 years old. I am UNABLE to afford the Trip to South Carolina to Stand Before the Courts and Fight this Violation of \$25.00. I live on a very Low Fixed income from Disability. My Trip from West Virginia to Florida, then Back to West Virginia is supported by my Mother for Gas/Food/Lodging, in which she Supports my Trip Twice a Year.

DEFENDANT'S DEFENSE:

I was driving back home to West Virginia From Sebring Florida visiting my Family for Christmas. I picked up my Friend, Ronnie Kenner in Brunswick GA as my Passenger on my way home Northbound to West Virginia. Ronnie Kenner also Witnessed All Accounts set forth herein this letter with all Actions taken place by Mr. McAdams.

On the Date of 12/27/2014 around 2:15pm Just before Entering into North Carolina North Bound on I-77 while still in South Carolina in the Center Lane, my Cruise Control was set Exactly at 60mph as the Posted Speed Limit.

Mr. McAdams came upon me Quickly on the Left Fast Lane and Tagged along Side me on my Left Side for just over 1/4 of a mile Starring at me, While doing so Mr. McAdams came Very Close to Side Swiping my Car Causing me to Cross the Dividing Line into the Right Lane of traffic in Which I had another Car to the Right Side of me in which also had No Choice but to moved to his far right side of his lane. Then Mr. McAdams turned on his lights to pull me over.

Mr. McAdams asked me if I knew Why I was being pulled over..

I said: No

Mr. McAdams said because I am not wearing my Seat Belt.

I Grabbed my Seat Belt to Show him that I AM Wearing my Seat Belt, that I keep it tucked under my Arms because it Cuts into my Neck over my shoulder being such a Small Car and my Seats sit Really Low, It's how the car is Made sitting very low by the manufacture.

Mr. McAdams Still Charged me for NOT Wearing my Seat Belt.

Mr. McAdams said that my Seat Belt Has to be Over my Shoulders, and it is the Manufactures Specification to my Vehicle.

My Passenger was Also Wearing his Seatbelt under his arms and was NEVER Charged, nor did Mr. McAdams care to see if my passenger was wearing his Seatbelt or not.

I collected the Violation from the hands of Mr. McAdams and Preceded back on the Interstate in the Center Lane Setting my Cruise Control back to 60mph as the Posted Speed Limit.

Mr. McAdams did the Same Thing AGAIN Tagging Along side my car on my left side, Swerving back and forth close to my car again and again for almost 1 mile Intentionally Aggravating the Situation.

Within this Time I had NO CHOICE but to take my hands off the Steering Wheel to relax my Seatbelt enough to Show Mr. McAdams that my Seatbelt is INDEED Over my Shoulder While Driving at 60mph to get him to Leave Me Alone in Which was putting Myself and my Passenger and Other Motorist in Danger to have yet ANOTHER Accident..!

AFTER I Showed Mr. McAdams that my Seatbelt is Over my Shoulder driving 60mph he Continued to Interrogate for over 1/4 mile until Finally Mr. McAdams drove past me to several cars ahead of me. Mr. McAdams Switched into Two Lanes to the Right of Heavy Traffic WITHOUT Signaling in Front of the other Cars causing All Of Us to Hit our Brakes just so he can get off at the Next Exit, Thus Almost Creating yet ANOTHER Accident.!

During this time my Passenger was looking at all the other cars, most had SC and NC Plates and my Passenger Pointing out to me how many was NOT Wearing their Seatbelts..

With this said, Myself and my Passenger is Convinced that Mr. McAdams Targeted us and VERY PREJUDICE to People like us that live in West Virginia, And Mr. McAdams Purposely Created a Hostile Environment, not once, But Several Times to Force me to Have a Accident based on his Careless Actions in Behavior and POOR Driving Abilities, Endangering Himself, Me, and ALL other Motorist surrounding the Scene.

I have called my Step Father when I got home, Officer Robert Brooks whom works for the Florida Highway Patrol in Sebring Florida for Over 30 Years. I asked My Step Father about the Ticket that Mr. McAdams gave me, his Behavior and Actions against Myself and My Passenger, and ALL OTHER Motorist that we was Surrounded by.

My Step Father told me there is NO LAW On how I wear my Seatbelt, and NO State in the Entire Nation can Charge me with this Violation..

My Step Father, Myself, and my Passenger all Agree that Mr. McAdams is Making up his Very Own Personal Rules, and Writing UNLAWFUL Violations Against Myself and Possibly Other Motorist. We ALL also believe that this is not the First Complaint Filed Against Mr. McAdams.

I Looked up the South Carolina State Violation Codes, and it does NOT Say anything in Details on HOW I should Wear my Seatbelt..

For your Convince, A Copy of Your State Code:

“SECTION 56-5-6520. Mandatory use of seat belt.

The driver and every occupant of a motor vehicle, when it is being operated on the public streets and highways of this State, must wear a fastened safety belt which complies with all provisions of federal law for its use. The driver is charged with the responsibility of requiring each occupant seventeen

years of age or younger to wear a safety belt or be secured in a child restraint system as provided in Article 47 of this chapter. However, a driver is not responsible for an occupant seventeen years of age or younger who has a driver's license, special restricted license, or beginner's permit and who is not wearing a seat belt; such occupant is in violation of this article and must be fined in accordance with Section 56-5-6540.

HISTORY: 1989 Act No. 148, Section 47(A); 2001 Act No. 65, Section 2."

SUMMARY:

Myself, my Passenger, and ALL of my Family Members and Friends AGREE to the Following:
Mr. McAdams Needs to Take Time off from his Position as a Officer of the Law Until he can get his Personal Affairs and/or Temper/Conduct in Order, so he can Conduct his Job Title Properly and Professionally, And without Endangering Innocent Motorist, And not be Prejudiced to Out of State Motorist that is Abiding by ALL Laws, as I did NOT Violate Any Laws.

Mr. McAdams is an Endangerment to Himself and the Safety to All Motorist being on Traffic Duty. Mr. McAdams Careless Actions Creating a Hostile Environment while Driving 60mph almost causing me to have a Accident Several Times, and UNLAWFULLY Charging me with a Violation, as well as His Behavior - We ALL AGREE that Mr. McAdams is a Disaster to Himself and the Safety to Others, and needs to Take a Human Behavioral Class in your Local Community College, that Mr. McAdams needs MORE Training with Drivers Education based on his Inadequate Driving Abilities.

We ALL Feel that Mr. McAdams Is Suffering somesort of Personal Issues with his Home Life and/or his Romance Affairs and/or Personal Problems within his Department of Law Enforcement based on his Poor Attitude towards People, and CARELESS Driving, and Taking his Frustrations out on Innocent Motorist.

We as LAW ABIDING Citizens should NOT have to Suffer and PAY for Mr. McAdams Erratic Behavior and his POOR Driving Skills, Nor do I feel I should PAY for Mr. McAdams Decisions Making up his Very Own Personal Rules of the Law.

With Mr. McAdams being so Determined that He is Correct with his PERSONAL BELIEFS in Traffic Laws, then Why couldn't he of just wrote a Simple Warning Ticket, and Just Let it Go..?
WE ALL Feel that Mr. McAdams is Not Conducting himself Professionally with his Job Title, and Sets a Poor Example for the State of South Carolina as well as his Fellow Officers.


As Mr. McAdams Stated "Quote - Your Vehicle Specifications are to Have the Seatbelt Over your Shoulder - Unquote."
