### Webinar: Helping Connect Individuals to Benefits: Approaches, Tools & Promising Practices

The National I&R Support Center is hosting a webinar on Helping Connect Individuals to Benefits: Approaches, Tools, and Promising Practices. This webinar is scheduled for **Tuesday, January 24, 2017, from 3:00 p.m. to 4:00 p.m. ET.**

Despite the availability of public benefits programs that can help meet basic needs and improve economic security, many low-income older adults and younger adults with disabilities are under-enrolled. In this webinar, the National Council on Aging (NCOA) will present findings from a recent study on how stigma affects perceptions of these programs, and results from a national survey of what messages can effectively counter stigma. Participants will also see how NCOA's newly redesigned online screening tool, BenefitsCheckUp®, can assist with identifying benefits. The National Association of States United for Aging and Disabilities (NASUAD) will present information about the current outreach campaign to individuals with disabilities that may be eligible for financial assistance through the Medicare Savings Programs (MSP) and Low Income Subsidies (LIS). Participants will learn about promising practices for providing outreach to low-income Medicare beneficiaries to increase enrollment in Medicare savings programs. Presenters for this webinar will be Brandy Bauer, Communications Manager, Center for Benefits Access, National Council on Aging and Linda Nakagawa, Policy Analyst, NASUAD.

## Gaps in the Evidence on Employment and Training for Low-Income Adults

Mathematica Policy Research released an issue brief, published by U.S. Department of Health and Human Services, Administration for Children and Families, Office of Planning, Research and Evaluation, that examines different employment strategies for low-income individuals. The Employment Strategies for Low-Income Adults Evidence Review (ESER) was used to evaluate employment and training interviews for this population. Included in the brief are recommendations about how to bridge the gaps found in employment and improve service design and program delivery.

#### Grant: Using Robotics and Automation to Improve Accessible Transportation

The Administration for Community Living's National Institute on Disability, Independent Living, and Rehabilitation Research (NIDILRR) announced a new grant opportunity, Using Robotics and Automation to Improve Accessible Transportation Options for Individuals with Disabilities, under the Disability and Rehabilitation Research Projects Program (DRPP). The purpose of this grant is to further the applications of automated products and robotics to assist with transportation for people with disabilities and to improve the overall traveling chain to meet the needs of travelers with disabilities. All applications must be electronically submitted by **March 21, 2017**.

#### ACL Issues Guidance for Outreach and Services for Holocaust Survivors

The Administration for Community Living's Assistant Secretary on Aging released guidance to the Aging Services Network as required by the Older Americans Act of 1965, P.L. 114-144. Between 100,00 and 130,000 Holocaust survivors reside in the



United States, most have significant support needs that are unique from their counterparts in the same age group. This guidance provides promising practices for outreach and providing services to this population. Specifically, the guidance focuses on "mental and physical health, nutrition, transportation, caregiver support, outreach, legal and ombudsman services, with a foundation in person-centered, trauma-informed approaches." Experts in the field contributed to the creation of the guidance.

## Centers for Medicare & Medicaid Services

### CMS Releases Final Rule for Medicare & Medicaid Home Health Care

On January 9th, the Centers for Medicare & Medicaid Services (CMS) released the final rule, Medicare and Medicaid Program: Conditions of Participation for Home Health Agencies. Home health care offers coordinated services to patients in their own homes under the care of a physician. Included in the final rule are changes to the conditions of participation (coPs) that home health agencies HHAs are required to meet in order to participate in Medicaid and Medicare programs. The final rule includes several changes like the addition of a comprehensive patients rights condition of participation, a patient assessment requirement, integrated communication systems, and more. The regulations will become effective on **July 13, 2017**.

## **HHS Issues Guidance for Electronic Information Technology**

On December 21, 2016, the United States Department of Health and Human Services' (HHS) Office for Civil Rights (OCR) issued a letter of guidance regarding equal access to all health services and benefits for electronic information technology. Medical technology is being rapidly integrated into the healthcare system and it is of the utmost importance that these methods are accessible for all individuals. Unfortunately most of the Electronic and Information Technology (EIT) devices and systems are not accessible for individuals with disabilities, which violates Section 504, Section 1557, and Title II of the Americans with Disabilities Act. The letter provides specific guidance regarding websites, medical kiosks, and electronic health records.
