Good morning,
SCDSS has been asked for Lutheran Services to approve a 10% increase in arrivals for this federal fiscal year. As you will recall, the FY16 resettlement number for LSC was 200. In or around January 2016, after consultation, we indicated support for a 10% increase from 200 to 220 arrivals. This would be a second 10% increase to 242 to accommodate the increased number of refugee resettlements approved by the federal government for the country. Email from LSC is below.
