### Governor Nikki Haley News:

**The State:** Gov. Nikki Haley files for re-election

After filing for re-election Tuesday, Republican Gov. Nikki Haley hopes lower unemployment and a record of bringing jobs wins her another four years in the Governor's mansion.

**Note:** "This administration has worked hard as we possibly can to improve the lives of all people," she said before meeting with volunteers at the S.C. GOP headquarters. "I represent all people. I fight for all people. And we have done that by putting all these jobs in rural counties."

Sen. Larry Grooms, a Berkeley County Republican and chairman of the transportation committee, said he believes if and when the Senate takes up a bill with a bevy of funding options in proposed amendments, many of them may be struck as not germane to the main bill, meaning it will take some other means to get much funding passed.

**Note:** Haley, who is running for re-election this year, has threatened to veto any bill that includes a gas tax increase. She has suggested that lawmakers use the difference between initial and final state revenue estimates, typically more than \$100 million a year, to fund road and bridge needs.

**Note:** Gov. Nikki Haley's signing of a temporary order allowing larger loads to be carried by logging trucks — up to 90,000 pounds gross per vehicle versus the usual 80,000-pound limit — should "ease a bottleneck of trucking capacity to get salvaged material to the mills (pulp mills, saw or stud mills, biomass plants)," Gammell said.
