RE: Your Letter of August 18, 2009 re: Cassie Weeks

Dear Mr. Brown:

Your letter of August 18, 2009, addressed to our Estate Recovery unit was forwarded to me for a response related to the DHHS Form 1296ER and the privacy issues related to information regarding Cassie Weeks.

Under both the Medicaid confidentiality regulations at 42 CFR 431.300 et seq, and the Health Insurance Portability and Accountability Act (HIPAA) Privacy Rule, 45 CFR Part 164, the South Carolina Department of Health and Human Services a(SCDHHS) can only provide information related to Cassie Weeks or any other possible Medicaid recipient if we have an authorization from the recipient or it has been demonstrated that the requester has the authority to act on behalf of the possible recipient. This requires either an executed power of attorney or appointment as the conservator or guardian of the person in question. Absent such authorization we cannot provide any information to the requester.

I can tell you that our estate recovery process follows the requirements of both state and federal law related to estate recoveries. The state law can be found at Section 43-7-460 of the South Carolina Code and the federal law is found at 42 USC 1396p. Neither law requires that the state or the agency obtain any documents from Medicaid recipients. SCDHHS created the 1296ER form to serve as an acknowledgement that recipients were provided information on the estate recovery program. It is not and was not intended to be anything more than documentation for SCDHHS that the recipient was advised about the estate

recovery program. It has no legal impact and does not create or abrogate any legal right for either SCDHHS or the recipient. It only documents for SCDHHS that our procedure related to providing information regarding estate recovery was followed.
