UPDATE: On June 15, 2016, shortly before 2:00 p.m., the escaped juveniles were seen walking near the area of Dorchester Road and Ladson Road by a concerned citizen. Dorchester County Sheriff's Office deputies were in the area and attempted to apprehend the juveniles. A short foot chase ensued and subsequently the juveniles were taken into custody without further incident. The juveniles will be transported back to the Charleston County Sheriff's Office to be interviewed by our detectives. They both will be charged as adults. The charge will be Escape.
