David, Austin—

Mr. Magill asked that I let you know the Department's response to date concerning the tragic events at Townville Elementary.

The Department's Anderson-Oconee-Pickens (AOP) Community Mental Health Center Assistant Director is currently at the Church where students and staff were evacuated following the shooting to make known the availability of Center Services.

The Center has a School-based counselor assigned at Townville Elementary. That counselor, and two additional clinical staff from the Center, will be available to the students, teachers and staff when School resumes. Anderson County activated their Disaster Response Operations Center and the AOP Disaster Preparedness Coordinator is at the Operations Center.

Other DMH Community Mental Health Centers in the Upstate, as well as the Department's Harris Psychiatric Hospital in Anderson, have all offered whatever additional resources to the AOP Mental Health Center as they may need to assist the Community.
