OSMBA recognizes that the State's level of success in accomplishing its procurement goal with Minority Business Enterprises is directly related to each agency successfully meeting its goal of spending at least 10% of your total dollars of funds expended with certified MBE's. We applaud the productive efforts of agencies contracting with South Carolina's women and minority-owned businesses.

We also acknowledge that agencies should be given an opportunity to re-submit their MBE goal for fiscal year 08/09 to reflect your current adjusted budgets. If the State issues additional budget adjustments during this current fiscal year, agencies will submit to OSMBA their adjusted MBE Plan within 30 days of the adjustment. OSMBA staff is available to answer questions concerning your agency's MBE reports or inquiries on how to improve your actual MBE procurement opportunities.
