### Governor Nikki Haley News:

**Associated Press:** Haley, GOP governors ask FCC to address prison cellphones

Gov. Nikki Haley is among 10 Republican governors urging the head of the Federal Communications Commission to give states more autonomy in fighting the issue of cellphone that inmates have illegally in prison. Haley on Monday wrote to FCC Chairman Thomas Wheeler encouraging him to give states "flexibility and authority" to deal with the issue, universally seen as a security threat. States need FCC permission to block cell signals, and Haley has been vocal in her opposition to required FCC approval. Testifying last month at an FCC field hearing in Columbia, Haley said the state had tried multiple other methods, but none are as effective as blocking.

**Note:** The letter was also signed by governors from Alabama, Georgia, Indiana, Maine, Mississippi, Nebraska, North Dakota, South Dakota and Utah.

Ten Republican governors want the Federal Communications Commission to give states more autonomy to apply technology that can stop prison inmates from using smuggled cellphones. Gov. Nikki Haley and her counterparts encouraged FCC Chairman Thomas Wheeler in a letter Monday to give them "flexibility and authority" to render such communication impossible. While the letter doesn't explicitly say so, what the governors want is permission to jam cellphone signals behind bars.

Gov. Nikki Haley targeted cellphones in prisons in a letter recently sent to the Federal Communications Commission. Haley, along with nine other governors, signed the letter to FCC Chairman Thomas Wheeler on Tuesday, according to a news release. The letter asks the FCC to "streamline regulatory review processes" regarding contraband cellphones in prisons, and to allow states more freedom to act on the matter.

**Note:** Haley's cosigners on the letter included Alabama Gov. Robert Bentley, Georgia Gov. Nathan Deal, Indiana Gov. Michael Pence, Maine Gov. Paul LePage, Mississippi Gov. Gov. Nikki Haley is one of 10 governors to write the Federal Communications Commission asking for changes to be made in the way it handles contraband cellphones in prisons. Haley joined the

governors of Alabama, Georgia, Indiana, Maine, Mississippi, Nebraska, North Dakota, South Dakota and Utah. "The FCC should act to streamline regulatory review processes and allow states to implement cost-efficient technology in prisons, where the installation of such technology will not sacrifice the safety of the general public," the governors wrote in the letter sent to the FCC Monday.

Gov. Nikki Haley will most likely sign a bill banning women from having abortions at 20 weeks of pregnancy, but abortion rights supporters said they wanted lawmakers to know the public is taking note of the laws they pass. "We are urging Gov. Haley to veto this and have always been urging her to veto this bill," Alyssa Miller, spokeswoman for Planned Parenthood South Carolina, said during a Statehouse rally Tuesday. "This rally is to show both chambers that people are watching and people are paying attention." The General Assembly last week passed a bill that would keep women from having abortions after her pregnancy reaches 19 weeks, with no exceptions for rape or incest.

Abortion rights supporters are calling on Republican Gov. Nikki Haley to veto a bill banning most abortions in South Carolina past 19 weeks. About 50 people chanted "Stop the Ban!" during a rally Tuesday outside the Statehouse. Signs carried by protesters included those reading "Keep the elephant out of the womb" and "Don't tread on me" next to a drawing of a uterus. The Legislature gave final approval to the measure last week.

Chicago-based Opternative said Monday it has stopped operating in South Carolina, where state legislators overturned a veto of a bill that bans prescriptions based on its online eye tests. South Carolina is one of seven states where Opternative has hired lobbyists to fight legislation that might threaten its ability to operate. The South Carolina bill, which requires prescriptions for glasses or contacts to be based on an in-person exam, reached Gov. Nikki Haley's desk last week. In rejecting the bill, Haley said it "uses health practice mandates to stifle competition for the benefit of a single industry." On Wednesday, the South Carolina Senate voted 39-3 to overturn her veto, and the House voted 98-1 to do the same a day later.

Law enforcement agencies could not require officers to write a certain number of tickets under legislation advancing to the Senate floor with just two weeks left in the legislative session. The Senate Judiciary Committee unanimously approved the bill Tuesday. Sponsoring Rep. Justin Bamberg says quotas pressure officers to stop people for minor offenses, and his bill is a step in repairing relationships between law enforcement and the community.

A bill that would block law enforcement agencies from establishing ticket quotas for their officers or creating requirements for issuing citations continues to breeze through the Legislature and with overwhelming support. The measure received resounding approval Tuesday when the Senate's Judiciary Committee sent it to the floor on a 20-0 vote. The bill already passed the House of Representatives in April on a 99-0 tally. The bill's author, Rep. Justin Bamberg, D-Bamberg, acknowledged Tuesday, however, that while the proposed law would bar police departments from instituting a quota system, officials haven't carved out a penalty for departments which violate the mandate.

Nine members of the Greenville County legislative delegation have asked the Federal Trade Commission to investigate Greenville Health System's plans to expand. In a letter to the agency, the legislators say they are "very concerned that this plan will severely reduce competition in our health care marketplace, which will in turn have a negative impact on health care prices, health care quality,

on the poor, our local businesses and our community as a whole.” GHS spokeswoman Karen Potter said the hospital is not aware of any request for an investigation. She declined further comment.

A proposal to ban Berkeley County students from using the bathrooms of their choice is likely dead for the year after local senators blocked it on Tuesday. Berkeley Sens. Sean Bennett and Paul Campbell objected to the proposal on Tuesday. Campbell said that he is blocking the proposal to let local authorities deal with the issue. The proposal was opposed by many Democratic senators and Republican state leaders, including Gov. Nikki Haley and Superintendent of Education Molly Spearman. The S.C. Senate abruptly adjourned **last week** to block the proposal.

A lobbying blitz by top state education and economic officials who were worried that passage would hurt the state financially, pressured lawmakers to prevent a vote on the bill by adjourning early last week.

To the casual observer, it would seem that gay rights falls neatly on the political spectrum. Democrats champion bills that aim to protect LGBT people from discrimination, and Republicans increasingly propose and pass ones aimed to protect the religiously devout. But there's growing evidence that Republicans in Congress and across the country are sidestepping the more controversial religious protection and bathroom bills and, in some cases, embracing LGBT non-discrimination laws instead. Some, like GOP Reps. Charlie Dent (Pa.) and Rep. Ileana Ros-Lehtinen (Fla.), are even leading the way.

**Note:** Lynn says she'll try again next legislature. But higher-profile Republicans like Donald Trump and South Carolina Gov. Nikki Haley (R) have all indicated these bills aren't worth the kind of economic, legal and political strife that tend to come with them. "I don't believe it's necessary," Haley said. "...Like it or not, South Carolina is doing really well when it comes to respect and when it comes to kindness and when it comes to acceptance. For people to imply it's not -- I beg to differ."

The MOX facility, a product of an American-Russian nuclear agreement, is under construction at the Savannah River Site south of Aiken, and is the subject of a South Carolina lawsuit against the U.S.

Department of Energy. The agreement outlined nonproliferation responsibilities that each nation would dispose of 34 metric tons of weapons-grade plutonium.

House Republicans on Tuesday reprised their probe into four-year-old missteps by the Internal Revenue Service, making a detailed case why Commissioner John Koskinen should be impeached in a colorful hearing that underscored conservatives' suspicion of the agency. The two-and-a-half hour hearing, on accusations that Koskinen lied under oath to lawmakers and flouted a congressional subpoena, also was a reminder of a bitterly divided Congress. Few Democrats showed up for the proceeding before the House Judiciary Committee, but those who did said Republicans were wasting taxpayers' time and grandstanding on an old issue that would go nowhere.

IF A LEGISLATOR who is a criminal defense attorney is pushing a change to the DUI law, we understand that there might be a conflict between his interests and the public's interest. And that is the driving force behind the four-year push to require our legislators to tell us the sources of their income. But there's a big difference between agreeing that the public needs to know more about legislators' personal finances — which is where we seem finally to be in South Carolina — and deciding precisely what that means.

Horry County officials are planning to appeal FEMA’s proposed flood insurance rate maps that declare the community of Bucksport, Socastee areas and numerous other neighborhoods along the Intracoastal Waterway as flood zones. Horry County Stormwater Manager Tom Garigen says the federal agency wants to raise the flood elevation level from six feet to as high as 13 feet in locations that have never flooded. “Historically, we’ve never seen any flooding of the nature they’re talking about in Bucksport, even though there were huge storm events in this basin in 1928 and 1945,” Garigen told the Infrastructure and Regulation Committee of the Horry County Council Tuesday.

Virginia Gov. Terry McAuliffe said Tuesday he's confident he followed the law in accepting donations that now appear to be part of a federal criminal investigation. McAuliffe defended his actions to reporters, a day after a law-enforcement official told The Associated Press on Monday that McAuliffe

is the subject of a federal investigation looking at donations to his 2013 gubernatorial campaign. McAuliffe said he believes the investigation centers around a donation connected to a Chinese businessman, Wang Wenliang. Federal law forbids foreigners from contributing to U.S. political campaigns, but McAuliffe said Wang has held a green card for nearly a decade and is a legitimate donor.

Louisiana is poised to become the first state in the nation to expand its hate-crime laws to protect police, firefighters and emergency medical crews — a move that could stir the national debate over the relationship between law enforcement and minorities. If signed by the governor, the new law would allow prosecutors to seek additional penalties against anyone convicted of intentionally targeting first responders because of their profession. Existing hate-crime laws provide for more fines and prison time if a person is targeted because of race, gender, religion, nationality, sexual orientation or affiliation with certain organizations.

Donald Trump holds his first presidential fundraisers this week. The events directly benefit his campaign, but he doesn't see it that way. Trump insists that his about-face from self-funded candidate to one who relies on donors is happening only at the request of the Republican National Committee. "The RNC really wanted to do it, and I want to show good spirit," Trump said in a phone interview with The Associated Press. "Cause I was very happy to continue to go along the way I was."

Hillary Clinton and Bernie Sanders dueled for support ahead of California's presidential primary on Tuesday as the Vermont senator showed few signs of backing off as he sought to boost his longshot odds for the nomination. Sanders' campaign launched a \$1.5 million ad buy in the state and announced that it would seek a recanvass in last week's Kentucky primary, where he trailed Clinton by less than one-half of 1 percent. The recanvass, which is not a recount, involves reviewing the election results but is unlikely to change the results or the awarding of delegates.

**Associated Press:** Forensic expert suggests explosion downed EgyptAir jet

Body parts recovered from the crash of EgyptAir Flight 804 showed signs of burns and were so small



that they suggested the jet was brought down by an explosion, a member of the team examining the remains said Tuesday. But the idea of a blast was promptly dismissed by the head of Egypt's forensic agency as "baseless" speculation. The cause of Thursday's crash of the EgyptAir jet flying from Paris to Cairo that killed all 66 people aboard still has not been determined. Ships and planes from Egypt, Greece, France, the United States and other nations are searching the Mediterranean Sea north of the Egyptian port of Alexandria for the jet's voice and flight data recorders, as well as more bodies and parts of the aircraft.
