Thank you for your letter of recent date concerning your reinstatement fee. We are enclosing your reinstatement requirement sheet.

While I sympathize with your situation, the Department of Motor Vehicles is required by law to collect a \$100.00 reinstatement fee for each suspension under Section 56-1-390 of the South Carolina Code of Laws. As a result, the department does not have the authority to waive reinstatement fees.

You may pay the reinstatement fees in increments of \$100.00 as you are able to do so and we will apply it to one of the suspensions on your record until all reinstatement fees have been paid. Your license will remain suspended until you meet the above requirements.

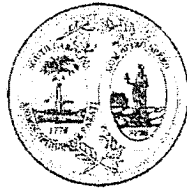
