SUMMARY REPORT

Meeting of Commission on Higher Education, August 5, 1982

ORGANIZATION OF FUNCTIONAL GROUPS

The Commission received as information a report by Mr. William T. Putnam, Executive Director of the State Budget and Control Board, on the organization of State agencies into "functional groups" to address specific areas of interest. The functional groups are expected to be key components in the development of policies, objectives, and priorities by the Budget and Control Board for use in the budget process. The postsecondary education functional group includes, in addition to the Commission on Higher Education, the public senior colleges and universities, the State Board for Technical and Comprehensive Education, the Higher Education Tuition Grants Committee, and the Advisory Council on Vocational and Technical Education.

CAPITAL IMPROVEMENT REQUESTS

Two capital improvement requests were approved by the Commission: (1) Request to Purchase House Adjacent to Campus for Office Space, Clemson University; and (2) Request to Lease Warehouse Space, Lander College.

ALLOCATION OF 1982-83 DESEGREGATION FUNDS

The Commission received as information a report that the State Budget and Control Board, on August 4, 1982, approved the Commission's recommendations on the allocation of 1982-83 desegregation funds appropriated for implementation of the State Desegregation Plan.

SUMMER CAMP FOR ACADEMIC DEVELOPMENT, WINTHROP COLLEGE

Dr. Glenn C. Thomas, Interim President of Winthrop College, reported on the Summer Camp for Academic Development at Winthrop. The three-week Summer Camp, supported by desegregation funds, is conducted for a selected group of high school students who have completed the ninth grade. A minimum of 60 percent of the students admitted to this program are black.

ANNUAL REPORT ON PROGRESS IN HIGHER EDUCATION DESEGREGATION

The Commission approved the 1982 annual report on progress in implementing the State Desegregation Plan, required by the U.S. Department of Education annually during the life of the Plan.
