Subject: Final AmeriCorps Funding Recommendation

Hello Commissioners and Committee Members,

Tim and I were able to speak with our CNCS Program Officer and she informed us of the following:

- 1) City Year will remain funded at the Competitive level.
- 2) WINGS for Kids will remain funded at the federal level as a National Direct program (A good thing).
- 3) The Vet Corps grant will not be funded competitively.

This information confirms that Scenario #1, the most likely scenario, is the funding recommendation that will need to be approved by the UWASC Board of Directors during their quarterly meeting this Friday. I have attached a copy the Final Funding Recommendation for your review.

As we expected, this funding scenario left \$39,620 on the table. Since we want to make sure to spend every last penny of our Formula allocation, these leftover funds were allocated evenly among the two new programs (UW Low Country and Sumter) in order to help cover initial start-up cost. These programs will be expected reduce their cost/MSY for the FY14 competition.

If the SC Commission is successful in obtaining supplemental funds in September, those funds will be used to support the Vet Corps program.
