







PA - Category B - Funded in 30 days

Hazard Mitigation (HM)

Hazard Mitigation (HM) Community Education and Outreach (CEO): Advisors, in 31 DRCs, provided personal/property risk reduction information /advice to 299 survivors. Cumulative interview total is 6,299. Outreach in Lowes and Home Depot stores advised a cumulative total of 2377 customers and approached 5364.

Flood Recovery Office (FRO): Completed 95 quality checks on claims and completed Community Compliance Monitoring in 28 communities.

Hazard Mitigation Dam Assessment Team: Continue to develop/provide dam analytical technical assistance/documentation.

Substantial Damage Estimator (SDE): Performed 215 inspections in Sumter and Richland Counties. Cumulative total to date completed is 1,850. Remaining total 9,358 out of 11,200 to be completed (Goal).


- EHP Staff supported the State of South Carolina during Applicant Briefings in Dillon and Calhoun Counties.
