### Department of Administration passed by Senate and House:

**Associated Press:** Restructuring bill heading to governor's desk

A bill called the largest restructuring of state government in two decades is finally heading to the desk of South Carolina Gov. Nikki Haley. The Senate approved 39-4 on Tuesday a compromise worked out last week by a panel of Senate and House members. The vote came hours after the House gave unanimous approval. The votes give a victory to both Haley and her Democratic opponent, Sen. Vincent Sheheen, the bill's main sponsor.

Martin asked to hear what the governor thought and tried to adjourn the senate. He feared the senate would vote on restructuring if he left the floor to speak with Haley. Senators voted to stay in session, but they agreed to recess while Martin, Sen. Tom Corbin, R-Greenville, and Senate Majority Leader Harvey Peeler, R-Cherokee, met with Haley in her office. After their 20-minute meeting, Martin thanked Haley for talking with him "on a personal level" and ended his blocking of the bill.

South Carolina's Senate and House both overwhelmingly passed on Tuesday a fundamental restructuring of the state's government, but not before a state senator demanded — and received — a meeting with Gov. Nikki Haley. The bill's passage also means a bipartisan compromise between two gubernatorial candidates — Haley and presumptive Democratic nominee Sen. Vincent Sheheen, whose colleagues praised him for shepherding the bill.

An increase in motorcycle-related fatalities has driven three state representatives to file a bill that would require all riders wear helmets. House Bill 4500 was filed Wednesday by Reps. Wendell Gilliard, Carl Anderson, and J. Seth Whipper, D-North Charleston. Gilliard and Anderson said it's time Palmetto State residents consider such a measure because state roads are getting crowded.

**Note:** At the time, Gov. Nikki Haley also threatened to veto Anderson's bill, had it been approved by the legislature. Haley's stance on the matter has not changed since, said her spokesman on Thursday.

S.C. Sen. Darrell Jackson, D-Richland, introduced a bill Tuesday to raise S.C. teacher pay to the national average. The bill so far has the support of four Republicans and five Democrats, including Gov. Nikki Haley's likely Democratic challenger, Sen. Vincent Sheheen of Camden. Jackson said he is not sure yet how much money increasing teacher pay will cost the state. Budget forecasters are working on those numbers, he said.

Legislators say the South Carolina Department of Transportation needs to do a better job repairing potholes and responding to other constituent complaints to prove it can spend any extra allotment correctly. The agency has said it needs an additional \$1.5 billion yearly over 20 years to bring roads to good conditions.

S.C. employers would have to pay workers at least \$1 an hour more than the federal minimum wage and adjust the minimum wage based on inflation each year if bills filed Tuesday pass in the General Assembly. The bills, introduced by six Democratic state senators, allows workers to file complaints about employers who fail to pay the minimum wage. Businesses have 15 days to give unpaid wages before legal action is taken.

An NAACP official suggested Sen. Tim Scott of South Carolina, the only black Republican in the Senate, is a GOP puppet. "A ventriloquist can always find a good dummy," said Rev. William Barber, president of the North Carolina NAACP. "The extreme right wing down here finds a black guy to be senator ... and then he goes to Washington, D.C., and articulates the agenda of the Tea Party."

**Note:** "To reflect seriously on the comments a person, a pastor, that is filled with baseless and meaningless rhetoric would be to do a disservice to the very people who have sacrificed so much and paved the way," Scott said in a statement. "Instead, I will honor the memory of Dr. King by being proactive in holding the door for others and serving my fellow man. And Rev. Barber will remind me and others of what not to do."

The judge, prosecutor and defense lawyers all agree that justice, at least by today's standards, wasn't carried out 70 years ago when a 14-year-old black boy was sent to the electric chair for killing two white girls. But figuring out exactly what happened in March 1944 may be elusive, they said during the first day of a hearing into whether the boy, George Stinney, should get a new trial. People who attended the original trial have died and most of the evidence, including a transcript of the trial, has disappeared.

Higher-income Americans and some legally married same-sex couples are likely to feel the biggest hits from tax law changes when they file their federal returns in the next few months.
