

Was the “anonymous tipster in the Los Angeles area”, who sent this “letter and a detailed map” to the “FBI Field Office in Columbia, S. C.” concerning Elizabeth and John Calvert actually Frank Watson’s “GOOD FRIEND” who lives in California? In early 2000, while Frank was working for me at the Crown Plaza hotel concrete resurfacing job in Hilton Head, he told me one evening at my office that he had a “GOOD FRIEND” in California in response to my statement to him that my brother Bill lives in Georgia and my brother Jim lives in California. As you know, but criminally ignore:

1: Frank Watson introduced me in Feb./Mar. 2000 to his friend Dennis Gerwing. Frank told me that he had been doing QuickBook accounting work for Dennis for several years and owed him a lot of money. In early 2000, Frank introduced me to Dennis, who introduced me to Mark King, who introduced me to Elizabeth and John Calvert, who gave me the contract to install an **Increte** epoxy floor embedded with crushed oyster shells., per **Mike Richey's** advice, at their Hilton Head Island lighthouse.
