(Columbia, SC) – The House Opioid Abuse Prevention Study Committee that House Speaker Jay Lucas (District 65-Darlington) appointed in April will hold a public hearing on Wednesday, August 16, 2017, in North Charleston, SC.

**WHO:** The [House Opioid Abuse Prevention Study Committee](#) is tasked with developing recommendations identifying preventive measures and increasing treatment and recovery options to better protect South Carolinians from opioid abuse.

**WHAT:** The House Opioid Abuse Prevention Study Committee will hold a public hearing in North Charleston, SC, to hear public testimony regarding personal experiences and the impact of the opioid epidemic.
