



We will be glad to pay any expenses associated with the copying of responsive documents. We also will send a courier for pickup of any documents responsive to this request upon notification that the same are ready.

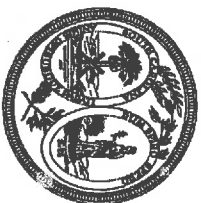

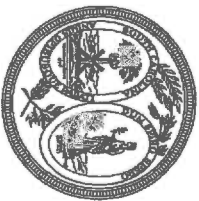
