## **Surplus Property Public Notice**

**July 15, 2005**

In accordance with the State of South Carolina Statue 57-5-340, by this publication the Department is making public the Surplus Property Real Estate Transactions to the State Highway Commission. The following sheets include a breakdown of surplus property real estate transactions. These transactions may have resulted from negotiations with property owners during right of way acquisition, direct sales, settlement of a condemnation action, and/or corrective actions to previously reported sales.

1. File MSC 284 / Road S-1297 / Greenville County / Fourth District

The Department acquired approximately 0.41 of an acre of land in the City of Greenville, in Greenville County from Calhoun Street Investments Company, Inc. by Title to Real Estate dated November 27, 1973, and from Georgia M. Vaughn by Title to Real Estate dated May 21, 1993, to construct the Downtown Loop. The project was never built and the property was later assigned as MSC 284 and used as the right of way office.

The District Engineering Administrator of District 3, with concurrence of management, has determined that MSC 284 in the City of Greenville is no longer needed and should be liquidated from the Department's inventory. After receiving approval from the South Carolina Budget and Control Board, the property was given to a Real Estate consultant to market to the general public. The Grantee made an offer above the appraised value. Therefore, a Quitclaim Deed for approximately 0.41 of an acre of land to AID Upstate was executed on June 14, 2005, in consideration of \$90,000.00.

2. File 32.128A / Road S-378 / Lexington County / Second District

During construction of improvements on Road S-378 (Airport Road), under File 32.128A in Lexington County, near the Town of Springdale, the Department acquired right of way for Road S-378 by Title to Real Estate from Parks Auto Service, Inc. dated December 27, 2001.

During negotiations to settle a difficult acquisition case, the Department agreed to convey the remainder of Tract 2 to the adjacent owner in exchange for some new right of way needed for the project. Therefore, a Gratis Quitclaim Deed for approximately 0.13 of an acre of land to Dexter Christenberry, Jr. was executed on June 17, 2005.

## **Professional Services Recommendations**

The following sheets include recommendations for the Department to utilize professional consulting firms to provide various services, which may include design, right of way acquisitions, construction engineering and inspection, or other associated services. The Department requests approval from the Commission to advertise, select and negotiate for these necessary services.

- 1] I-26: Bridge over SC 302 in Lexington County (1 structure) (2nd Congressional District)
- 2] S-23-102 Bridge over Armstrong Creek and S-23-969 Bridge over North Saluda River in Greenville County (2 structures) (4th Congressional District)
- 3] SC 34 & S-16-133: Bridges over Black Creek in Darlington County (2 structures) (5th Congressional District)
- 4] US 301/321: Bridge over Salkehatchie River in Allendale & Bamberg Counties (1 structure)(2<sup>nd</sup> & 6th Congressional District)
- 5] SC 170: Bridges over Beach Hill Canal, Canal, Laura Hill Swamp, Little Back River, Savannah River Overflow, Savannah River Swamp in Jasper County (6 structures) (2<sup>nd</sup> Congressional District)
- 6] S-13-20: Bridges over Unnamed Stream and Bear Creek in Chesterfield County (2 structures) (5th Congressional District)

The Department requests Commission approval to advertise and select a consulting firm or firms for the purpose of providing engineering services for the replacement of the above bridges. Based on current and projected workload, the Department does not have sufficient staff to proceed with these projects.



**REQUEST FOR PROFESSIONAL ENGINEERING SERVICES:**

The Office of Planning requests Commission approval to seek consulting services to update the Statewide Transportation Plan. The Statewide Transportation Plan should be comprised of three components including; Corridor Plan Analysis, Mass Transit Plan, and Railroad Right of Way Preservation Plan. The budget is estimated at 1.5 million to be funded by State, Planning, and Research (SPR) funds.

### **Removal of Roads From State Highway Secondary System**

The Department recommends Commission approval for the removal of certain sections of secondary roads from the State Highway Secondary System. These sections of roads may be removed for one of the following reasons:

1. Abandonment of Relocated Section of Highway
2. Deletions and Removal of Roads from State Secondary System - Roads may be deleted and removed from secondary system by exchanging for equal or less mileage or roads, which have a higher traffic importance. Ownership reverts to local government having jurisdiction (city or county). Approval of deletion or removal by local government is not required.
3. Abandonment of Right-of-way - Right-of-way may be abandoned if it is determined that the right-of-way is not required for right-of-way proposes or if the right-of-way is not needed for Department purposes.
4. Court Order
