### SUMMARY REPORT

Meeting of Commission on Higher Education, September 5, 1985

The Commission approved the following capital improvement requests: (1) renovation of dormitory facilities for men's athletic program, USC-Columbia; and (2) lease of additional facilities for Speech and Hearing Clinic, USC-Columbia.
