My laptop went missing in an incident whereby a group of people trying to KILL ME, never-stopping..by which I have NO ESCAPE... on this occasion...knowingly USED the Easley City, SC (Pickens County) police department to arrest and illegally detain me (PERSONALLY, purposefully and cruelly unjustly manipulating local LE to their own end) FOR 2 weeks in April/May 2016.

As well as unidentifiable and unidentified people posing to be you, the FBI, President Obama, secret service, friends and family (listed below). My family is likely 100% involved, yet continue to lie, decieve, and hurt everyone they come across...and continue to torture me and everyone that I come across.

Please help. Again, I've got no where else to turn and my parents explicitly told me to never call "911" from within their home ever again...so, now I'm on the run without a home, still unable to receive help from law enforcement -- state or federal, or even make or keep friends or family anywhere I go...

I'm basically dead to the world. And it's their world, not mine. And all I've tried to do is live and let live...

Help...I'm alive. And have no one to turn to. No matter where I go, who I'm with, etc. they're always here. Hurting me, torturing me, killing me and whoever I'm with. No matter who they are or what they do...

I have no where to turn -- and my life is being ripped away from me by people that I love... Due to sheer hatred, apathy and bigotry. They will stop at nothing to obstruct justice, hurt me or kill me and be anything but family or friends.

Can you please direct me to anybody that may be able to assist me?

S.C.'s Governor, SLED, SCEMD, Greenville County Sheriff's Office, Anderson County Sheriff's Office, Easley City police, Pickens County Sheriff's Office, York County Sheriff's Office, Mackleburg County Sheriff's Office, Abbeville County Sheriff's Office and Charlotte City police have and were all involved in this hate-fueled campaign that only aims to hurt, sabotage and eventually destroy my life and anyone around me...

Thank you for your time. I can't stop these less than human people and they will not stop at anything to watch me suffer, die and hurt without end AND ensure the same happens to everyone that I meet. They are PURE EVIL and I need help to live and survive....
