

**State Funds expended for Opioid Abuse**

Funding: Medication-Assisted Treatment

To: S.C. Department of Alcohol and Other Drug Abuse Services (DAODAS)

From: State of South Carolina

Amount: \$1.75 Million

Spent: Awarded for State FY 2017

This funding will be for the expansion of medication-assisted treatment of opioid use disorder at state-funded alcohol and other drug abuse treatment facilities.

Funding: Prescription Drug/Opioid Overdose Prevention

To: S.C. Department of Alcohol and Other Drug Abuse Services (DAODAS)

From: SAMHSA

Amount: \$665,665 per year for 5 years

Spent: Awarded September 2017

This funding is for The SC Overdose Prevention Project collaboration between DAODAS and DHEC to train first responders, and caregivers of individuals suffering from opioid use disorder on the identification of opioid overdose and the reversal of overdose with the overdose-reversal drug naloxone. These funds will equip law enforcement in high-need areas with the life-saving drug.

Funding: Medication-Assisted Treatment (MAT)

To: S.C. Department of Alcohol and Other Drug Abuse Services (DAODAS)

From: SAMHSA (SAPT Block Grant funds allocated by DAODAS for MAT)

Amount: \$27,500

Spent: For State FY 2016

This funding is for medication-assisted treatment of opioid use disorder at state-funded alcohol and other drug abuse treatment facilities.

Funding: "Strategic Prevention Framework – Partnerships for Success"

To: S.C. Department of Alcohol and Other Drug Abuse Services (DAODAS)

From: SAMHSA

Amount: \$880,000 per year for 5 years

Spent: Awarded October 2015

Outcomes will be based on the needs that each community determines must be addressed. This is primary prevention funding that will be spent in four counties in South Carolina that have identified non-medical use of prescription drug use among youth ages 12-25.

Funding: "Prescription Drug Overdose Prevention for States"

To: S.C. Department of Health and Environmental Control (DHEC), Bureau of Drug Control

From: CDC

Amount: \$1.3 Million for 18 months

Spent: Awarded April 2016

This funding is intended to: 1) Enhance and maximize DHEC's prescription drug monitoring program (PDMP); 2) Target innovation in health systems for increased use of the PDMP; and 3) Evaluate mandatory use of the PDMP.

Funding: "Electronic Health Records (EHR) and PDMP Data Integration"

From: SAMHSA

To: DHEC Bureau of Drug Control

Amount: \$424,000

Spent: All funds spent or committed

Outcomes: The PDMP has been integrated in two health systems. One of the two health systems has one hospital integrated in the emergency department. One health system has four hospitals and 20 ambulatory care centers integrated. All integrated sites have seen increased use of the PDMP.

Funding: "FY 2016 Substance Abuse Service Expansion Technical Assistance"

From: HRSA

To: Family Health Centers, Inc.; Hopehealth, Inc.; Little River Medical Center, Inc.

Amount: \$1.1 Million

Spent: In March 2016, funds were committed to three Federally Qualified Health Centers in South Carolina.

This funding is intended to improve and expand the delivery of substance abuse services provided by existing FQHCs, with a focus on medication-assisted treatment of opioid use disorders.

Funding: "Medication Safety Matters"

To: South Carolina Pharmacy Association

From: BlueCross BlueShield of SC Foundation

Amount: \$500,000

Spent: Awards were granted on April 25, 2016

This funding is intended to begin a statewide campaign for public awareness and prescriber education on prescription opioid safety.
