## From NASUAD

### Materials Available Online from I&R Center Webinar on Data & Outcomes

On Wednesday, November 2, the National I&R Center hosted a monthly webinar on the data and outcomes from a national survey.

As I&R/A professionals know, good data is critical to achieving good outcomes for the individuals and families that you serve. As part of a data study for the state of Colorado, NASUAD recently conducted a national survey of State Agencies on Aging and Disabilities and Medicaid Agencies to assess the status of data collection and outcome measurement for services for older adults and persons with disabilities, and to highlight important trends, developments and practices. The survey also touched upon structure and location of ADRC/SEP/NWD systems.

Participants of the webinar learned about these key findings, including information on systems for consumer access to long-term services and supports. The webinar was presented by NASUAD's Senior Director Damon Terzaghi. The slides from the presentation, a copy of the audio recording, and a transcript are now available online.

### New Fact Sheet: Certification for I&R Specialists - Aging/Disabilities

Certification for Information & Referral (I&R) specialists recognizes the knowledge, skills and professionalism of I&R practitioners. In response to frequently asked questions regarding certification for I&R specialists who work in aging and disabilities, NASUAD, the Alliance of Information and Referral Systems (AIRS), and the National Association of Area Agencies on Aging (n4a) partnered to develop a fact sheet on the Certified Information and Referral Specialist-Aging/Disabilities (CIRS-A/D) certification that is offered through AIRS. The fact sheet addresses key questions including eligibility for certification, the application process, recertification, and the roles of national partners. ## **Medicaid & CHIP: Applications, Determination, & Enrollment**

The Centers for Medicare & Medicaid Services (CMS) released their monthly report for August 2016 on Medicaid and CHIP application, eligibility determination, and enrollment data. States provide data to CMS on factors related to key application, eligibility and enrollment processes using the Medicaid and CHIP Performance Indicator Project. The data is then used to inform CMS on the operations of the programs in each state and to share state performance data publicly.

## Centers for Medicare & Medicaid Services

### **Updates to Medicaid LTSS and Section 1915(c)**

On Wednesday, November 2, 2016, the Centers for Medicare & Medicaid Services (CMS) released the *Medicaid Long-Term Services and Supports Beneficiaries 2012* report which provides updated estimates of the number of people who receive Medicaid long-term services and supports (LTSS). Additionally, CMS released annual updates to two reports that describe recent section 1915(c) Home and Community Based Services (HCBS) waiver program data. *Medicaid 1915(c) Waiver Data Based on the CMS 372 Report, 2012 - 2013* identifies the number of people who received HCBS waiver program services, and Medicaid expenditures and duration of service for participants during 2012 and 2013. The other report, *Medicaid Expenditures for Section 1915(c) Waiver Programs in FY 2014*, provides data and trends regarding waiver expenditures.

### AARP Public Policy Institute

#### New Report on Family Caregivers and MLTSS

To kick off National Family Caregivers Month, the AARP Public Policy Institute has issued the first major research report on family caregivers' needs within the emerging field of managed long-term services and supports (LTSS). The authors find that while family caregiver supports are still uncommon in managed LTSS, managed care contracts can lead the way in standardizing a person- and family-centered approach, resulting in better care for both members and their families.

This research offers:

- Practical tools and guidance for care coordinators and providers who work for health plans;
- Policy recommendations and model managed care contract language to benefit members with self-care needs and their family caregivers; and

- Promising practices from TennCare, South Carolina Healthy Connections Prime, United Healthcare, and Cal MediConnect Dementia Project.

## American Health Care Association

### Lawsuit Filed to Challenge Arbitration Rule

On October 17, 2016, the American Health Care Association (AHCA), the national trade group for nursing facilities, the Mississippi Health Care Association, and three LTC facility providers filed a lawsuit against the Centers for Medicare & Medicaid Services (CMS) over implementation of a recent final rule that revises the requirements LTC facilities must meet in order to participate Medicare and Medicaid. The new rule makes a number of changes, including prohibiting LTC facilities from signing pre-dispute arbitration agreements with residents, which essentially resulted in residents waiving their right to sue the LTC facility. The AHCA maintains that prohibiting these arbitration agreements is illegitimate due to other Federal law, and is requesting that the courts stop enforcement of the provision after the effective date of the rule on November 28, 2016.
