Federal and State Collaboration to Improve Health Through Housing

State and federal policymakers increasingly acknowledge that health is difficult to achieve and maintain for people without a stable home. The cross-sector nature of efforts to provide health care, housing, and housing-related services to vulnerable populations can make it difficult for health and housing policymakers to align and coordinate their work. With support from The Commonwealth

Fund, federal and state policymakers met in December 2016 to identify concrete policy recommendations and actionable steps to align programs to ensure that people with high service needs receive the housing and supportive services they need to become and stay healthy. State Legislation Action on Pharmaceutical Prices Map Updated

As the 2017 state legislative sessions kick off, NASHP is continuing our work tracking [legislative action](#) on pharmaceutical pricing. Last year, states introduced dozens of bills on pharmaceutical prices, and the trend is expected to continue in 2017. A series of maps and accompanying chart summarize

state legislation across six major “themes,” transparency, reimportation, pharmacy benefit managers, volume purchasing, research, and price regulation. These tools are the part of the [NASHP Pharmacy Costs Workgroup](#), an ongoing project that looks beyond the strategies currently used in states to identify and develop new ideas, which address the growing problem of prescription drug costs.

Webinar: Primary Care Provider Burnout: What States Need to Know and What They Can Do About It

February 8, 2017, 3:00 PM - 4:00 PM ET

As primary care practices struggle to keep up with the growing demands of a constantly changing healthcare environment, states experience increasing difficulty recruiting busy practices to participate in delivery and payment reform demonstrations. This trend mirrors increasing rates of provider burnout. Using the experience of the [Heart of Virginia Healthcare](#) (HVH) as a lens, this webinar will provide an overview of the scope and impact of provider burnout, particularly as it relates to state health policy and what states can do about it. HVH is one of seven regional cooperatives reaching 1,500 primary care practices nationwide as part of the Agency for Healthcare Research and Quality's [EvidenceNOW](#) initiative. With the anticipation of more changes to our health system, it is more important than ever for state officials to have an

awareness of primary care burnout and to consider a proactive response.
