to work because he has so

long periods. He had open  
heart surgery when he was 29  
years old. He has a metal  
device for a mechanical  
heart valve for his Aorta. He  
has to take out cumadin to  
keep his blood thin enough to go  
through this device to empty  
his heart of blood & pump it in.  
If he gets dental work or teeth  
pulled he has to have a specialist  
to do the work, which cost a  
lot of money. I don't have. I am  
65 on Social Security & retired  
from the State of S.C. with 32  
years. I can't possibly pay his med-  
ical bills & medicine. I'm about  
to lose my 1 bedroom Condo ~~the~~  
now, after buying his medicine  
& supporting him & his 15 year old  
son.

He was in a wreck that broke ~~he~~ every bone in his ~~bone~~ foot & caused him to have a sciatic loose leg. These hurt him every day if stands for long. He also has had his back broke & has three titanium bars & eight screws in his back. It bothers him every day. We have tried to get him on disability & they said — He's not blind, he can walk. I got a lawyer & she gave him the papers to fill out so she could take the case. He can't get the papers filled out because we don't have the money to pay to the orthopedic specialist that operated on his back or the Cardiologist that did his surgery on his heart. We can't pay the doctor that operated on his foot.

We are in vicious ~~surgery~~ <sup>circle</sup>. He can't get Med-aid because he filed for Social Security disability. We can't get food stamps. He is in the process of divorce. His son has no health care & we can't get any. We get turned down every where we go.

I know plenty of people on social security disability that have far less wrong with them than my son. I could name names if it comes to that.

Must I ~~lose~~ lose everything I have because I pay his medical bills & medication. It is not cheap. I'm 65 years old. I worked hard all my life on a tobacco farm & 32 yrs for the Henry Co. School District.

My son owes back taxes for 2012 & 2013. Its only about \$900 & I sent in the papers to the ~~IRS~~ IRS begging to make a payment of \$40 a month. I don't have cash on hand to pay the \$900 in one payment. I haven't heard a word from them. When I called the number on the form I <sup>was</sup> received from them they put me on hold for 40 mins & sometimes they say we suggest you try again ~~tomorrow~~ tomorrow. The volume of call are so heavy. I never get to talk

to them. What can I do?  
This has been going on for  
years. Do we have to pay  
the whole amt. ~~to~~ he owes  
the IRS before he can file  
again?

In the meantime he  
should be seeing a cardiologist  
& he cant because we ~~do~~  
dont have the money.

I am worried sick for years  
now. He goes to a family friend  
Doctor who is just a M.D. We  
appreciate what he does by  
testing my sons blood every  
two weeks but he is not  
a Heart doctor or orthopedic  
specialist

We ~~are~~ need help. before  
I lose my son. Hes only 41  
My daughter died at 17. She  
was killed by a drunk driver.  
My <sup>ex</sup> husband was killed in  
a farm tractor accident in  
2006. I have no one to help  
me.

I need your help! I
