Earlier this morning I received the monthly report from the Department on State on refugee arrivals in South Carolina this past month. Between November 1 – November 30, 43 refugees from 7 countries were resettled in South Carolina. None of the refugees resettled last month were Syrian. 24 of the 43 individuals resettled last month were male and 19 were female. Additionally, 17 of the 43 individuals were minors under the age of 18.

**Subject:** October 2016 Refugee Arrivals

David,

As I shared on the phone, over the weekend I received the monthly report from the Department of State regarding refugee arrivals in South Carolina between October 1 – October 31, 2016. During the month of October 2016, 19 refugees from four different countries (Honduras, Iraq, Syria and Ukraine) were resettled in South Carolina. Of the 19 individuals resettled, 10 were female and 9 were male. Additionally, 10 were minors (ages 0-17) and 9 were adults.

Eleven of the individuals resettled were of Syrian national origin. The eleven individuals were comprised of two family groups: one group of two individuals and one group of nine individuals. It is our understanding that the two family groups are related. These two groups of individuals were assured to Lutheran Services Carolinas in October 2015 and, therefore, are from the previous federal fiscal year. Of the 11 individuals of Syrian national origin, two are over the age of 60 (one male/one female), three are adults (ages 18-59; two female and one male) and six are minors. DSS has not yet received case information sheets on these 11 individuals and were first notified of their arrival on Friday.
