SECTION 7: The Minutes for the meeting of March 21, 1991; copies of which have been previously mailed to each member of the Commission, were approved.

SECTION 8: The Commission unanimously passed a motion accepting monthly reports as published by the Department of activities for the month of March, 1991.

SECTION 9: The Commission unanimously passed a motion approving purchase orders issued for amounts in excess of \$10,000.00 during the month of March, 1991, as shown in the Appendix.

SECTION 10: The Commission unanimously passed a motion authorizing the Department to advertise and select a consulting engineering firm to provide consultant services to develop and implement a maintenance management system for statewide use at an estimated cost of \$500,000, as shown in the Appendix.

SECTION 11: The Commission unanimously passed a motion awarding a contract to Columbia Cooling and Heating Company for installation of additional cooling systems at the headquarters facility in Columbia at a total cost of \$172,158.00, as shown in the Appendix.

SECTION 12: The Commission unanimously passed a motion authorizing the Department to participate with the North Carolina Department of Transportation in a feasibility study of the I-77/I-85 Connector at a cost not to exceed \$100,000, as shown in the Appendix.

SECTION 13: The Commission unanimously passed a motion authorizing the transfer of \$466,867 from the Ordinary Maintenance Allotment/General Ledger Number 6210.000 to the Maintenance Signal Installation Allotment/General Ledger Number 6240.000, as shown in the Appendix.

SECTION 14: The Commission unanimously passed a motion approving the allocation of approximately \$7,000.00 to install an open panel workstation for the Administrative Assistant in the reception area of the Executive Director's office, as shown in the Appendix.

SECTION 15: The Commission unanimously passed a motion approving the allocation of \$841.74 to reupholster five chairs located in the Executive Director's office, as shown in the Appendix.
