Dear Governor Haley,

I am a former middle school English teacher and can honestly say that I have not been happy since my position was horribly taken away from me in May 2010.

Please allow me to explain and thank you in advance for indulging me.

For five years, I have been trying to become a full time teacher again, fighting against The State Department of Education "Red Tape" until it's made me physically ill – but I have kept fighting.

Here's my story. I became a teacher through the Palmetto Alternative Certification Program (PACE) in 2008 with a Critical Needs Certification in English. I had taught as a long term substitute teacher in the Spring of 2007 prior to applying to the program because I loved teaching, love the kids and loved knowing that I was doing something good to help our leaders of tomorrow.

I was hired by then principal Mary Clark to teach at Conway Middle School. My classroom duties began in 2008 with my first sixth grade class. It was fabulous. Those students will be graduating from high school this year and have invited me to come to their graduation. I accepted with great joy.

I was rehired at Conway Middle School for a second year in 2009. Unfortunately, I became ill soon thereafter. Without going into gory detail, I had to be out of work some and continued to get sicker.

As a part of the PACE program, there are continual classes that you have to take throughout the two year program. (They call them cohorts – that information is attached). I had finished the cohorts and all of the assignments which I passed with flying colors, but the day of the wrap up meeting, I was very ill.

I was scheduled to have surgery a few days later, and was told by my physician that I was feeling worse; he told me not to travel to the meeting. Although I didn't feel like going, I went anyway but was late. (all information regarding the surgery is attached)

I made the required presentation the day I was tardy, but that wasn't good enough. I was told that I would have to attend a full day "make-up" session to complete the PACE program. I was sick – I had had a hernia repair burst and intestines were coming through the broken repair which made me nauseated, dizzy and fatigued, to say the very least.

Long story short, I was unable to make the first makeup class and requested a second, to be taken after my surgery and recovery. I was denied that second make up meeting.

I managed to pull it together to help the students participating in the Christmas Pageant and went to the school to apply makeup and help with costumes as I also did. Principal Clark came storming into the room where I was assisting the students and told them to get out. She then told me to get my things and get out. Even though she knew how sick I was – she fired me on the spot.

Afterward, I was forced to meet with Mary Clark, the HR Director for the Horry County Schools at the time Ed Curlee and the then Superintendent Cynthia Elsberry.

They grilled me as if I was on trial. They treated me as if I had done something terribly wrong – like setting the school on fire or molesting a child. They were accusatory, unreasonable and devastatingly hurtful. They verbally attacked me.

The superintendent put me on paid leave until I could get an audience with the Horry County School Board to ask for my job back. When I finally was able to do that in May of 2010 – they told me that I should have made the meeting and I was fired.

There was complete disregard for my health.

There was complete disregard for my standing in the community and the parents and students that loved and respected me.

There was complete disregard for the fact that I taught homebound children and tutored in my classroom afterschool two days a week to help children improve their reading and writing skills – using my own personal books, supplies and materials of all kinds.

I was a dedicated teacher who went out of my way to help students in any way that I could and they knew they could count on me – anytime they needed me.

I think that is what good teachers are supposed to do

I was devastated, embarrassed and humiliated when I was publically fired. They told me I could not work in the Horry County School District again.

I have completed the course work, the cohorts, the tests and was late for a final day session of the nearly two year program. I had four months of Adept left (which is being mentored periodically in my classroom by another teacher ) and had the PLT to take and I would have received a teaching certification.

I substituted at Bridgewater Academy after the recovery from the surgery during the fall of 2010-2011 school year. I tried to get a full time job there, but they required a teaching certification.

I took a permanent – part time substitute job with the Georgetown School District in early 2012 and worked for them until I moved to the upstate of South Carolina in August of 2013. My father was dying and I needed to help my mother and spend as much time with him as possible.

In the meantime, I was offered a position in the Marion County School District in the late fall of 2012, but the teacher who was planning to leave the school, decided to stay. A letter from that principal is included in this packet.

All during this time, I was trying to get back into the PACE Program. As you will see from the documentation attached, I consistently received the runaround.

The last letter I received from Colette Reamer State PACE Coordinator was after she finally got the letter she needed from the new Human Resources Director from Horry County indicating I left in "good standing".

Reamer told me that I would be accepted into the program again, but that I would have to start the program from the beginning to include taking and passing the Praxis in English and paying the \$350 admission fee. They would not grant me any time whatsoever for time "served". I'm pretty sure I started to cry and threw the letter in the trash can. I knew I couldn't do that. I am the single mother of a daughter with a deceased father and couldn't afford the time or the money. I felt lost and that's when I decided to contact you.

So, this is where I sincerely need your help.

I started teaching in 2007 it's 2015. I've spent a lot of my life trying to recreate a career that was wrongly taken away from me....and in the meantime I've lost a lot of money and sanity. Seriously, I went into the hospital several times with a nervous breakdown!

Because I can't go back through the PACE Program, the only way I can see that I will be able to teach is to get my Masters in Communications. I would be honored to teach on a middle or high school level wherever I am needed.

I have also researched teaching on a college level and do know that it's only with a Masters that I can teach on a college level. I know there is a great need for Communications Instructors.

I have worked as a Radio News Anchor and Reporter, as well as a television talk show host and have more fifteen years experience in the field. I have a degree in Broadcast Journalism from Louisiana State University, although I grew up right here in The Great State of South Carolina.

With my teaching background and my news/communications background, is there any way that you can help me streamline the track to success in the field of Communications with teaching experience, radio and television experience and time already devoted help me?

I know that you have a Communications and Public Relations division for which I'm certain I would be a great asset. I know what talk show hosts say about you and your programs from the news side, I'm sure I would be able to handle "them" from your side....and make sure your "Great Day In South Carolina" mantra is positively maintained.

Governor Haley, I want to feel like I'm doing something good for others again and frankly reading news on the radio daily about deaths, child molestations, teachers having sex with students, fires, etc...is very depressing. That is what I am currently doing and I get sick to my stomach every day!

I want to be a vital part of the Communications Industry – talking about the good your office is doing, USC is doing, our legislators are doing and things that our state is doing for our residents; or teaching students how to communicate effectively to become productive and efficient members of society.

I am not afraid of hard work and like to stay busy. I'm ready to face challenges head on. My vast experience as a researcher, investigative reporter, interviewer, anchor and public speaker gives me an edge in connected with the public. I also have a keen ability to stay on top of the issues that matter in people's lives.

There is so much good that I can do.

Please help me. I need a good job. The one I have now is part time and pays \$12.00 per hour, plus I've been living off partial unemployment which is running out this week. I am almost to the point of financial desperation.

My daughter is a sophomore at USC and is so busy there involved in so many leadership activities that I never get to see her. She is on council of her sorority – Kappa Delta and she is a Leader of the Orientation Leaders and works all summer. She maintains a 3.7 GPA and has caught the eye of President Pastidies (after planning, organizing and implementing the student council officer orientation ceremony last year as a freshman!). She was a page in the State House for Heather Ammons Crawford all of last year too. (funny, I was a page for two years when I attended Columbia College!)


I am very proud of her but never get to see her. I would love to move to Columbia! I'd get to see her some. She grew up in Myrtle Beach and was not happy when I moved to Easley. When she gets a break from school – she goes to see her friends at the beach, not to Easley, South Carolina.



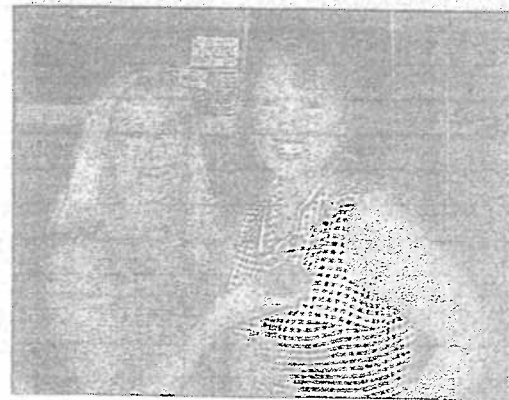
New officers chosen at the meeting were: Judy Blackburn,

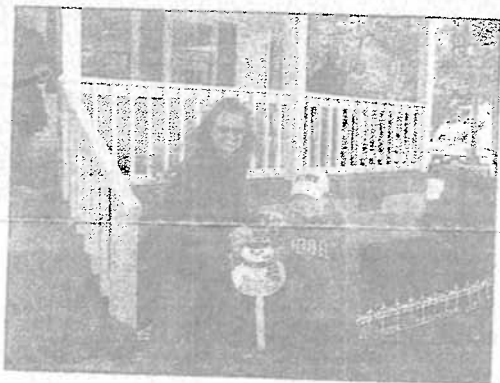
The Optimist Club is dedicated to helping local youth and makes donations to such groups as SOS, the YMCA and Miracle League.

This letter is to request readmission to the PACE program.

My desire to teach began when my own daughter started telling me that I would make a great teacher. She was in the sixth grade and is now a senior in high school.

I began substituting in the Horry County School District in November of 2007. I was offered a long term sub position in January at Forestbrook Elementary School for sixth grade ELA, then another one at St. James Middle School for the same. I took them both and realized that I loved it!

I taught full time at Conway Middle School 2008 to 2010 – while participating in the PACE program.

I completed all of the course work with PACE. Unfortunately, I didn't have an administrator that supported me during my first year – and into my second. Although I didn't have a mentor during my first year, I worked hard and my students did well. I was offered a second year there.

Also unfortunate, I became ill during my second year. I had to have surgery on my stomach in October, and was scheduled for another during the Christmas break. Because of this illness, I was late for the very last PACE wrap-up session in Florence. (I had to drive from Myrtle Beach) I had a doctor's note that stated I could not go due to my health issues.

I was also unable to attend the makeup session (for which Horry County supported me) in Columbia, but asked to be able to participate in that session after my surgery. That was denied by the same people who supported me originally. As such, I was dismissed from my job as a Sixth Grade ELA Teacher.

To say I was devastated is an understatement. I've worked for more than two years to overcome that devastation. I was told that I would not be able to teach again, but I've never given up!

I went through major surgery, a bankruptcy, losing my house, my ex-husband going to jail owing me thousands in child support, and overcoming depression. I never gave up on my dream of helping children reach for the stars and follow their dreams.

I have been teaching with the Georgetown County School District for the past eight months. After continually checking for Middle School ELA jobs in the area, I discovered that Marion County needed one. I answered the ad – they invited me over and asked me to take the position at Bridge Creek High School.

Teaching is my calling...and my goal is to make a positive difference in the lives of our future leaders.

To do so, I need to be back in PACE. I'd like to take the makeup session, and pick up where I left off with PACE, which involves taking three graduate courses and the PLT.





Dear Ms. Swinney,

Attached is a form that I sent you on the above referenced date...and send again today in hopes that you will forward it to the appropriate person.

In a nutshell, here's my story. I began teaching with Horry County as a substitute in October of 2007 – Hope Randall was and is a great advocate of the substitute program there and was always very sweet to me!

In January of 2008, I took a long term sub job for Mrs. Sweeny at Forestbrook Middle School (Margaret Sordian was the principal ((now at Conway Middle)), Paul Spadaro was assistant.((now at St. James Middle)) .Directly after that position, I took a long term sub job at St. James Middle School where Dwight Boykin was and still is the principal. I loved them both so much that I applied for the Palmetto Alternative Certification Educators Program through the state and was accepted.

Subsequently, I was hired to teach 6<sup>th</sup> grade ELA at Conway Middle School. As you are probably aware, a teaching job is required to participate in PACE. I love the subject and adored my kids; participated in school activities, taught homebound students, attended ballgames and school events, volunteered with the Drama Club and much more!

At the end of my first year, I began having problems with the former principal – Mary Clark. I didn't focus on them off thinking it was the end of the year and perhaps she just forgot to reschedule my "end of the year meeting" (required by PACE and ADEPT) and the rumors I was hearing from other teachers about her "talking about me" were just rumors. I was offered the position for the next year and I gladly accepted – excited about coming back.

When the problems continued during the fall of 2009, I tried to talk with her about them. She was unyielding in her opinions that there were no problems. I reached out for help – to Ed Curlee, your predecessor. The next thing I knew, I was fired – the day before Christmas break and three days before I had surgery scheduled. I was applying makeup to the kids participating in the Christmas Program and Clark came in and told them to leave and fired me on the spot, on a Thursday night.

There are a lot of gory details about what happened during the past three years regarding that firing, one of which I have over the past sixth months started coming out of with the help of professionals

At the end of my first year, Mary Clark, the principal at Conway Middle School forgot to reschedule my "end of the year meeting" (required by PACE and ADEPT) and rumors had started about Ms. Clark "talking about me negatively to other teachers"; however, I was offered the position for the next year and I gladly accepted – excited about coming back.

Problems continued during the fall of 2009 to include the lack of a full time mentor for Adept and mistreatment by Ms. Clark in front of my students and other teachers. Although I tried on many occasions to talk with her about them, she was unyielding in her opinions that there were no problems.

I reached out for help with the problem to Ed Curlee, your predecessor, with hopes of getting some help and working things out with Ms. Clark. The next thing I knew, I was fired – the day before Christmas break and three days before I had major surgery scheduled. I was applying makeup to the kids participating in the Christmas Program and Clark came in and told them to leave and fired me on the spot, on a Thursday night. My kids were devastated.

I appealed to get my job back with the School Board, but was denied readmission. The reason they said that I could not teach is because I was not in PACE, and the reason I was not in PACE was because Mary Clark had fired me and I was not teaching. She stated that she fired me because I was late for the final PACE class and could not make the makeup class. (Please see the notes from my surgeon regarding my health condition at that time.) There were no teaching issues involved.

I was unable to attend the makeup session for being late to that final PACE class (but was still there in time to make my final presentation). The reason I was late is because although my doctor/surgeon told me not to go because I was having major surgery a few days later and was very ill, I didn't want to miss it. The school district denied my appeal saying that I should have gone to the makeup meeting; they never took into consideration that I was extremely ill. Neither my abilities to teach or my teaching performance was ever in question.

After battling severe depression after I was fired, I began working with below average students at Bridgewater Academy Charter School in Myrtle Beach. When funds were cut for that program, I began substitute teaching in the Georgetown County School District. It was during that time that I was referred to a position at Creek Bridge High School in Marion County teaching 7<sup>th</sup> grade ELA. That was offered to me, but became unavailable as the previous teacher decided to come back. I had originally applied to reenter PACE when that teaching position was offered to me.

I was a substitute teacher in Georgetown County until the school year 2013 ended. I subsequently moved to the upstate of South Carolina because my family is here and my father has a life expectancy of less than a year. I went back into the broadcasting business upon my return, but still have a longing and desire to work with young people. I am a middle school Sunday school teacher and volunteer with the church youth, but want to be back in the classroom – making more of a difference!

Please see the attached reference letters for validation that I am a good teacher and truly care about the communication abilities, learning possibilities, welfare and lives of our future leaders.

Please see that I am worthy of continuing the PACE program and becoming a full time teacher again. I am a single mother, my daughter is a college student and I have all the time in the world to devote to our children.

I would very much appreciate your help. I have a lot to give these students and am hopeful that I can again become a positive part of their lives.

Please call me with any questions at 843-457-2616. I appreciate your prompt attention to this matter as I am more than ready to restart my teaching career. As a matter of fact, there are three open ELA teaching positions right now in the Greenville County School District for which I am applying. The problem is, I have to be enrolled to complete the PACE Program to be considered for a teaching position.

The South Carolina Department of Education needs the forms I am sending you to make that happen.


Here is my story told to you in hopes that you will help me.

This letter is to request readmission to the Program of Alternative Certification for Educators.

My desire to teach began when my own daughter started telling me that I would make a great teacher. She was in the sixth grade and is now a rising sophomore at USC.

I began substituting in the Horry County School District in November of 2007. I was offered a long term substitute position in January at Forestbrook Elementary for sixth grade ELA, then another one at St. James Middle School right after, for the same subject. I took them both and realized that I loved it!

I taught full time at Conway Middle School from 2008 to 2010 – while participating in PACE.

I completed all of the course work with PACE. Unfortunately, I didn't have an administrator that supported me the end of my first year and into my second. Although I didn't have a mentor during my first year in PACE and Adept, I worked hard and my students did well. I was offered a second year there.

Also unfortunate luck, I became ill during the beginning of my second year. I had to have surgery on my lower abdomen in October and was scheduled for another during the Christmas break. Because of this illness, I was just under two hours late for the very last PACE wrap-up session in Florence. (I had to drive from Myrtle Beach). I was able to make my required presentation.

My surgeon had provided me with an email, and subsequently several letters stating that I could not attend and why. He then provided statements regarding my illness and the resulting surgery.

I was also unable to attend the makeup session (for which Horry County School District supported me) in Columbia, but asked to be able to participate in that session after my surgery. That request was denied and I was dismissed from my job as a Sixth Grade ELA Teacher.

To say that I was devastated is an understatement. I worked for more than two years to overcome the devastation and depression that resulted. I was told by the Horry County School District that I could never teach in that county again. They truly treated me like a criminal!

After going through major surgery, a bankruptcy and loss of my home due to the loss of income, my ex-husband going to jail owing me thousands of dollars in child support and depression, I never gave up on my goal to help children reach for the stars and follow their dreams. (That was always my mantra!)

I taught with a charter school, substituted with the Georgetown Country School District and was offered a position in Marion County at Bridge Creek High School.

Teaching is my calling...and my goal is to make a positive difference in the lives of our future leaders. They need to know how to communicate, other than using cell phones to text! I am an excellent communicator with not only teaching skills, but broadcast and journalism experience, as well.

To teach, I need to be back in PACE. I'd like to take the makeup session and pick up where I left off which I understand involves taking three graduate courses and the PLT. I am prepared to do whatever it takes. I would also like to get my Masters in Education, when I have completed PACE.

I am enclosing information that I have sent to the Horry County School District, requesting completion of the readmission form. I included many reference letters and documentation from my surgeon regarding the illness and surgery which resulted in my inability to complete PACE.



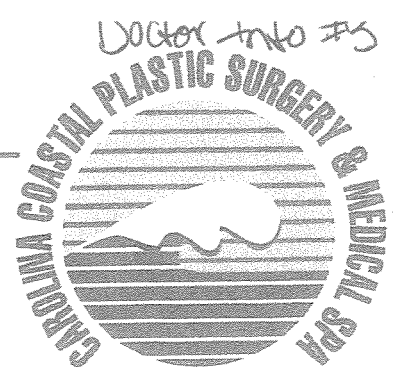

I am writing in support of Ms. Donna Roy and to confirm her recent problems.

Ms. Roy underwent surgery on October 29, 2009. The operation was planned to remove painful scar tissue from the area around her hysterectomy scar. She had been suffering with pain, which was exacerbated by standing, for almost two years.

Upon further examination of Ms. Roy, I discovered that she had been suffering from a possible abdominal hernia, which was later found to be a large foreign body mesh plug. Therefore, the first operation was limited and further surgery was planned.

Ms. Roy has been under my care since October 29, and I have advised her regarding rest, stress relief, diet, travel, and time allowed on her feet. The longer she stands, the more intense the pain. I have limited her driving because she has pain when using her right foot to brake.


I advised her not to attend the November 7, 2009 meeting in Florence and not to attend the November 30, 2009 meeting in Columbia because of the extensive driving involved.

Ms. Roy had surgery on Monday, December 28, 2009 to remove the scar tissue and repair a hernia and any further damage found. At that time a large plug of mesh was found that certainly resulted in her morbidity and subsequent pain which has increased over the last two years. She will continue to be under my care until further notice.

Please accept this medical explanation in support of Ms. Roy. I have known her for more than five years and found her symptoms reliable in view of my recent surgical discovery.

She has had a previous hernia repair in that area in the past and has had increasing pain in the area to the point where it has incapacitated her; affected her job which entails standing long periods of time; and even bothers her driving for moderate distances. She has been followed by me and has now on for exploration of this area today to see what the problem is. During surgery I found a very large dumbbell piece of mesh both scarred above her fascia and into her abdomen. This certainly could have been the cause of her pain.

DESCRIPTION OF SURGERY:  
The patient was taken to the operating room. After she was marked off prior to going in she was put to sleep under general anesthesia. She was thoroughly prepped with Betadine scrub and solution and draped off. The area was injected with 50 milliliters of 0.5% Marcaine with 1% Xylocaine, 1:2000 epinephrine and then an incision was made in a previous scar on her lower abdomen extended laterally in symmetrical fashion and she had a crooked scar that extended to the right superiorly and this incision was made to encompass the scar tissue. Large ellipse of skin was then resected down to the abdominal fascia

resecting fibrofatty tissue. A flap was elevated to the umbilicus using the special cautery making a flap over the abdominal fascia. When inspecting the right lower quadrant area, there was noted to be a very hard plaque area measuring approximately 4 centimeters in diameter with surrounding Prolene sutures. This appeared to be plug type mesh that was used to repair hernia and, which was causing her pain, scar tissue was extensively resected around this area and then using curved Mayo's, the plug was released from the fascia and cut across in the center using a knife. This was a dumbbell type of mesh that had been used to repair hernia. Once the top cap form of this plug was removed and then there was noted to be a plug form that was still within the hole and this was carefully dissected out re-creating a hernia. Once all the foreign body was removed and then bowel was easily seen and then a sequential repair using figure-of-eight 2-0 Ethibond sutures were used to repair the abdominal external oblique fascia, internal oblique fascia and the transversalis fascia and one closure several these Ethibond sutures were used to give a nice tight repair. The wound was inspected and there was no further defect at all. In fact, she had a nice secure repair from this and then the flap was brought back together using buried 3-0 Vicryl suture and a subcuticular 4-0 Vicryl suture followed by Steri-Strips and a dressing. The patient tolerated all procedure well.

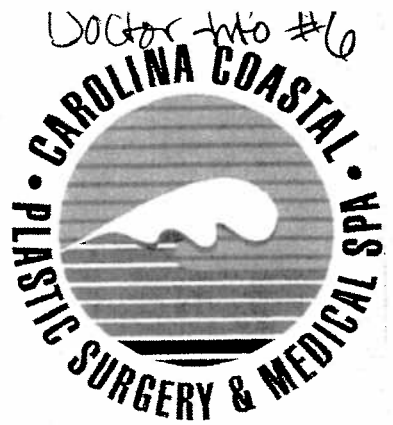



She had been suffering with this pain, which is exacerbated by standing, walking and/or driving-for almost two years. The abdominal pain became intense, and subsequently debilitating.

During one of my exams, I found a protuberant and painful mass that required open abdominal surgery with removal of a foreign body mass and correction of a hernia. These problems, symptoms, and surgery required necessary time out of work.

I hope this letter helps to clarify some of the issues in regards to reinstatement of her job. I feel that she has an excellent relationship with children and I have also asked her to tutor my own child Alex, so that she can stay ahead in reading and comprehension.
