I am contacting you on behalf of Trust Legacy Consulting LLC (TLC). TLC is currently involved in litigation with The Foundation for Special Needs Integrity, Inc. (The Foundation). The Foundation is a National Pooled Special Needs Trust with a Master Trust in your State. In the event we need to verify what The Foundation has provided to us through discovery would you please tell us what type of financial documents your state has concerning The Foundation?

In addition, we are contacting you because forensic auditors who have performed an audit of The Foundation's books and records have identified possible discrepancies between what The Foundation has paid TLC and what we feel is actually owed TLC. These discrepancies currently total over 1 million dollars including interest and penalties and are increasing daily. If you would like copies of the forensic auditor's records please let us know and we will have a copy sent to you. Since The Foundation's Master Trust for residents of your state has language that allows for payment of debts from the assets held in trust for your state residents, we may expect any debt which The Foundation cannot pay from its operating account be paid from those assets. According to the court ordered records we have obtained from The Foundation it appears that payment of this debt could substantially deplete the funds which are currently held in your state residents' Trusts.

It also appears that The Foundation may have and/or may currently be violating your state's Prudent Investor Rule by investing your state residents trust assets in only FDIC insured investments as stated on The Foundation's webpage at [www.specialneedsintegrity.org](http://www.specialneedsintegrity.org). If The Foundation is violating your State's Prudent Investor Rule The Foundation could **significantly reduce the repayment of any benefits to your state** from a deceased resident of your state who is or was a beneficiary of The Foundation's pooled trust. In addition, violating the Prudent Investor Rule would significantly decrease the earnings which your state residents have received and will receive which could cause an accelerated depletion of their trust's assets. If you are not the appropriate Agency to determine if the Prudent Investor Rule has been violated please either alert us to the appropriate State agency to notify and/or forward this communication to the appropriate governing body.

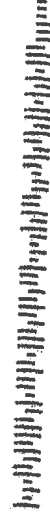

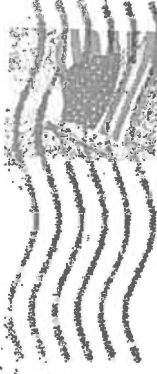
