- "News & Media" has been consolidated to one page with press releases as well as video and multimedia links

 Hank and I discussed some of the changes that need to be made to the Lt Gov Website last week. I have now put together some images to demonstrate some of the larger shifts of information. The Homepage changes are much as we already discussed, thought I would like to add the note that none of the menu items should have drop downs any longer.

As you see the is now an Information and Services page, this combines the old constituent services and programs pages. (also attached is an image to show how that information should be organized on the new page.

The Bio page is becoming the About page.

Emergency Preparedness is staying mostly the same, though I will be going through and reviewing all the links. (I ended up not merging this with Info and Services because it felt like to much information for one page.)

News & Media, the big things here are getting rid of the page of multimedia links and putting everything on the first

page after you click News & Media. (see image)

Finally, we need to add staff to the Contact Us page.
